Mayor Cashman announced that the purpose of the Public Hearing was to receive public comment regarding the allocation of RACP funds which have been awarded to the City. Mrs. Freenock noted that a recommendation for the allocation of \$500,000 to Warren General Hospital for its Maternity Ward Renovation Project is dependent upon a determination from the State Office of Budget as to whether those funds may be utilized for needed rehabilitation at the Clark Street Parking Garage.

Mr. Gilbert questioned whether \$2 million recommended for allocation to the Boat Launch Project are exclusive to that project or if funds would be utilized for development of areas adjacent to the launch. Mrs. Freenock indicated that the project would include as much as the \$2 million would allow.
