ROAD NEWS:

The road crew has more wood that needs split. **Supervisor Kelly VanCise made a motion to rent Jeff Carlstrom's wood splitter at \$50.00 a day Supervisor Kelly Ferrie seconds the motion. Motion carried with two votes, Supervisor Jeffrey Carlstrom abstained from the vote.**
