ROAD NEWS:

The title for truck #4 is being held up due to the state mixing up the plates with another township. We have to send pictures of the plates attached to the truck to Gibson Notary so they can get it straightened out with the state.

When the road crew isn't plowing they are going to start doing the oil changes on the equipment.

There is a lot of cold air coming through the front wall on the roadside at the township garage. The supervisors would like the road foreman to get a insulation quote from the company that put the insulation in the ceiling.

Gravel amounts for this year were discussed. Supervisor Kelly Ferrie made a motion to send out an RFQ for 424 tons of 2RC stockpiled and 1100 tons of No 8 Type C antiskid stockpiled both for more or less to be opened at the March 10 meeting Supervisor Jeffrey Carlstrom seconds the motion. Motion carried with three votes.

Oil amounts for this year were discussed. Supervisor Kelly VanCise made a motion to go out to bid for 13,500 gallons of HFMS-2 (E11-90) more or less to be opened at the April 14, 2021 meeting Supervisor Kelly Ferrie seconds the motion. Motion carried with three votes.

The supervisors discussed what to use the County Aid money for. Supervisor Kelley Ferrie made a motion to purchase HFMS-2 (E11-90) with the County Aid money this year Supervisor Kelly VanCise seconds the motion. Motion carried with three votes.
