The culvert pipe needs replaced on Coal Bed Rd. The secretary will send a letter to all the residents on the road, that the road will be closed to all traffic from 8:00 am - 3:00 pm on July 13 with rain dates of July 15 & 18. The road crew will place a sign at the beginning of the road at least a week in advance.

The wiring on truck 4 is a nightmare and needs rewired to get the lights to work properly. The road foreman will see where he can get an appointment at.

The secretary will contact the solicitor about increasing the road permit cost.
