ROAD NEWS:

The new chains are working good on truck 2. There was some discussion on piling used anti-skid that is swept up from the roads, in a separate area so residents can come and get buckets of it when it gets icy in the winter.

The road crew had to replace the broken water pump belt on truck 4.

Truck 1 is at Dyke's Garage. The road crew noticed that truck 1 may need rear springs, the garage will check it over and let us know.

Truck 2 will need belts in the near future, but not until the plow frame comes off. The alternator belt has been squealing and there is no adjustment left in it. **Supervisor Jeffrey Carlstrom made a motion to purchase belts for truck 2 Supervisor Matt Wallin seconded the motion. Motion carried with three votes.**

The garage will need another load of wood to get through the winter. **Supervisor Kelly VanCise made a motion to get another load of wood Supervisor Matt Wallin seconded the motion. Motion carried with three votes.**

The plow caught the side of the garage door. The road crew will straighten it out when the weather breaks.

Next year a damper will need to be added to the wood stove due to the fire bricks at the top of the stove starting to crumble.


The secretary gave an overview of an employment law workshop she attended.


