#### V UPDATES

- a) ATOD- Adam McNeill gave the ATOD update.

- In June we restart the planning with Sage Action Consulting on the new Prevention Plan.

- Cambridge Warren closed 12/31/23 and there were no issues with placements.
- Admissions to Warren State Hospital continue to increase.
- Working with Beacon Light on several individuals who have been court ordered to follow outpatient recommendations and the individuals are not following through.

- c) DD/EI- Adam McNeill gave the DD and EI update.
- There was a death over the weekend of a mother with an adult disabled son. Staff worked very hard to make sure the consumer was safe and all taken care of.
- Planning to review all client service plans as a result of what occurred this weekend. They will be reviewing each consumer's crisis plans and natural supports.
- Mary Hall will be retiring March 1, 2024 so they will be hiring a new EI Caseworker.
- **d) Managed Care-** There was no Managed Care update, however Lisa Babo shared that she is working on dates and meeting places for the 2024 Adult and Member meetings.
- e) Human Services Plan- There was no Human Services Plan update.

- Beacon Light has bed availability in Youngsville and can take referrals for local youth.
- Judy Baker asked about outreach in the community and Adam shared that it is being addressed in the Strategic Plan.
- Mark Rhoads, Forest County Adult and Child Probation, shared that Forest County schools are having a
  huge issue with vaping at school. Jen Gesing said she would talk to Prevention staff to see if they can
  do something. Lisa Babo also suggested that the Northwestern Tobacco Coalition could have some
  programming for them.
