Certification of the 2021 Millage Rate: Commissioner Benjamin Kafferlin stated that today we are certifying a millage rate of 21.75 which conforms to the 2020 budget.

Approval of the Agreement with Dr. Heeter: Commissioner Benjamin Kafferlin stated that this agreement is for the inmate health care.

Motion was made by Commissioner Tricia Durbin, seconded by Commissioner Jeff Eggleston to approve the agreement with Dr. Lonnie Heeter for 2021. Motion carried unanimously.

Approve the Maintenance agreement with Motorola: Kenneth McCorrison, Public Safety Director stated that this is a multi-year maintenance agreement for the equipment in the server room at public safety. This agreement saves the county \$14,000. He then expressed his thanks to Mr. Bill Gallagher for his help in getting the cost reduced even more.

Motion was made by Commissioner Tricia Durbin, seconded by Commissioner Jeff Eggleston to approve the multiyear maintenance agreement with Motorola. Motion carried unanimously.

Resolution #3175 Liquid Fuels 2021 Allocation: Pamela Matve stated that Warren County does not own any roads or bridges therefore the money we receive gets allocated to the municipalities. For 2021 we are allocating \$105,000 in liquid fuels and \$18,047.00 in bridge inspections for a total of \$149,405.00

Motion was made by Commissioner Tricia Durbin, seconded by Commissioner Jeff Eggleston to approve Resolution #3175 Liquid Fuels Allocations for 2021. Motion carried unanimously.
