# Warren County Commissioners Public Meeting February 8, 2023 12:00 p.m. Jackson Courtroom

Commissioner Tricia Durbin called the meeting of the Warren County Commissioners to order with Commissioner Benjamin Kafferlin and Commissioner Jeff Eggleston present.

**Executive meetings held since the last meeting:** There was one executive session since the last meeting to discuss legal and personnel items.

**Correspondence:** Phil Gilbert, Director of Tax Claim explained that Wilds are working initiative is a program through PA Wilds in an effort to bring workers to our area that work remotely.

**Resolution #3241 Adoption of GMS Standard Operating Procedures:** Commissioner Tricia Durbin stated that this resolution covers to policies and procedures, which are Vehicle Maintenance policy and Act 59(2002) Compliance Check.

Commissioner Benjamin Kafferlin stated that the vehicle maintenance policy is in place so that we can keep track of maintenance costs as we eventually get out of leasing vehicles. The Compliance Check is for our Law Enforcement officers to have a mental health evaluation after a traumatic incident.
