NEW BUSINESS:

1. <u>Lot width waiver – 30-foot road frontage waiver for Lot YV-929-6515 – Dunns Eddy Road - Brokenstraw Township – Lana L. Carlett & Linda C. Wolff</u>

Michael Lyon explained this item to the Commission. He said Vonnie Carlett owns two parcels on Dunns Eddy Road. The smaller lot is 2,178 square feet and the other is a little under 13,000 square feet. She is requesting a waiver to have the minimum width reduced from 80 to 50 feet. Her intentions are to have a subdivision completed taking 25 feet off of her larger lot and annexing 25 feet onto the second smaller lot to have a 50-foot-wide lot so she could potentially build a structure on that lot. As it is currently, the smaller lot is unbuildable. Mr. Lyon presented photos of the property. He measured some of the frontages for the adjacent properties and some are less and some are larger than 50 feet. In his opinion, what she is asking for fits the character of that area. A motion was made by Andy Brooks, with a second by Sheryl Vanco, to accept this waiver request. A vote was taken and all were in favor; motion carried.
