Jonie Smitley has been at the jail all morning addressing any questions from the staff and/or inmates. She has done a great job, and it shows that her answering the questions has put some inmates at ease.

Warden Jon Collins stated that he believes we are over the hump, and we can start opening up the dorms again. He stated that the courts and law enforcement have been fantastic at not brining people to the jail unless they have committed a serious crime.

District Attorney Robert Greene asked if there has been an issue with transporting the inmates that have been sentenced to state. Warden Jon Collins stated that there has been a huge issue with this; if the inmate tests positive we cannot transport.

Motion was made by Sheriff Brian Zeybel, seconded by District Attorney Robert Greene to approve the Warden's Report as presented. Motion carried unanimously.
