This property was declared blighted by the Blighted Property Review Committee in May 2022 and reviewed by the Planning Commission in December 2022. Ms. Bailey was invited to today's meeting, but she did not attend. She did sign the certified green card for invitation to today's meeting but the other certified envelopes are marked "Not deliverable as addressed" and "Unable to forward." There is an issue with the front porch. The understanding is that there is a tenant in the house. The 2021 taxes are delinquent. Phil Gilbert will look for an updated mailing address for Ms. Bailey. Pamela Matve will reach out to Sheffield Township to verify if there is a tenant in the structure.
