The electric is not hooked up, so the system is not functional yet. Ms. Matve read aloud the Analysis Report from Glade Township. see if there is any reason why it can't be removed from the RDA's Agenda, and, if so, the reason(s) why it can't be removed. A vote was taken and all were in favor; motion carried.
