Motion was made by Commissioner Tricia Durbin, seconded by Commissioner Jeff Eggleston to add an additional tax assessor position to the Tax Assessment office at a rate of \$15.00 per hour as set by the union contract.

Kim Exley, Employee Relations Administrator stated that the union is in agreement with this.

Commissioner Jeff Eggleston stated that the training time for these positions is a long time, and if we want to keep the tax rolls up to date, we need to get them help.

Dennis Munksgard, Treasurer asked if there was a need, as he does not know the needs of that office. Commissioner Benjamin Kafferlin stated yes, there is a need and it has been brought up during the budget meetings for several years now.

Dennis Munksgard, Treasurer asked when would this be effective to which Commissioner Benjamin Kafferlin stated immediately so that have time to fill.

Dennis Munksgard, Treasurer then asked if there was money in the budget for 2021 the answer was yes, there is money in the budget to cover should someone be hired this year.

After nothing further, the above motion was called to question and the motion carried unanimously.
