Open Bids 2024 Strategic Planning Program: Pamela Matve, Chief Clerk stated we received two bids for this project and they are as follows:

Kafferlin Strategies not to exceed \$ 58,625.00 Raftelis not to exceed \$114,250.00

Commissioner Tricia D. Durbin stated that we will need clarification on whether or not we can accept the bid from Kafferlin Strategies, as Benjamin Kafferlin was a former Commissioner up until December 2023.

These will be reviewed and any decisions will be made later.

Reassessment: Brian Bull, Chief Assessor gave an update on the reassessment progress: As of May 31, 2024, the data collection stand as follows:

Total residential data collected 16,379 (79.16%) Total vacant collected 3,083 (57.38%)

Inaccessible (gated, posted no trespass, etc.) 1,198 Refusals 263

Brian stated that he and Elizabeth have gone out to spot check to make sure the data collected is accurate, and all is good.

Limbing of tree on bike trail: Commissioner Daniel Glotz stated that there is a tree on the right of way that is dropping some larger limbs. Wally Harding has gotten three quotes and they are:

Bentley Tree \$ 900.00 or \$4,375.00 to cut down the tree

Mike Lindell Tree Svc. \$1,200.00 A&R Woodpecker \$1,491.00

These will be discussed with Wally and awarded at a later date.

Maximum agreement renewal: Pamela Matve, Chief Clerk stated that we have been with Maximum for about four years now, and it is time to renew for \$7,600 each year for 2023-2025.

Projects: Commissioner Tricia D. Durbin stated we are continuing to work on Broadband, and we are in support of the Verizon project. Also, Windstream has added approx—300 new households.
