Reassessment: Brian Bull, Chief Assessor gave an update on the reassessment progress:

As of August 5, 2024, the data collection stands as follows:

Total improved residential data collected 18,871 (91.21%) Total vacant collected 3,762 (70.02%)

Inaccessible (gated, posted no trespass, etc.) 1,466 Refusals 279

Brian stated that he and Elizabeth are going to spot-check to ensure the data collected is accurate and all is good. Also currently doing data collection of new construction in the City of Warren for the 2025 tax year.

Permittium Software: Sheriff Scott Neiswonger explained that this software will help in the license to carry permitting process at no cost to the county as all fees are passed onto those users who wish to do the online process.

This will cut down on the foot traffic to our office, and benefit those that wish to do the online process as they cannot make it to our office before closing.

Commissioner Kenneth Klakamp asked how many counties in the state are using this program to which Sheriff Scott Neiswonger stated 37 counties are using this.

Bill Gallagher stated that he was a part of the meetings, and not only is this no cost to the county, but it will reduce the postage costs of mailing things back and forth.

Sheriff Scott Neiswonger stated that even if someone does the online process, their application will not be processed unless all required information is completed.

Bill Gallagher then stated that there is no burden or security problem to our networking system.

Commissioner Kenneth Klakamp stated that there is a lot of time spent on carry permits, to check all references to making sure all the information is completed.

Holly Wescott, Director of Finance asked if there is any revenue from the carry permits to which Sheriff Scott Neiswonger stated yes, approx. \$3,200.00 and the county will still their fee.
