The Pennsylvania Department of Education has continued approval of the 2005/2008 program application for Alternative Education for Disruptive Youth under Act 30 of 1997.

I am pleased to inform you that the 2006/2007 school year grant under alternative education is in the amount of \$25650. The funding per student is \$1026.

Enclosed is the Amended Estimated Budget, with instructions, for completion and mailing. Please note that the budget page must be signed by chief school officer. Please complete and sign two originals and return them to the Department within 15 working days from the date of this letter to accept the 2006/2007 school year grant. **Please review the funded amount on the budget page carefully and reduce the grant award in red ink if you anticipate less student participation than was projected in April.**

The 2006/2007 grant amount has been calculated per student projected enrollment of Act 30 of 1997. The above grant award is provided for the purpose of defraying program costs incurred from July 1, 2006 to June 30, 2007. It is important to remember that although the grant funding is set aside for your school, Section 1093-C (3) permits the Department to reimburse schools based on the number of students who actually participated in the program. *Quarterly Reports* must be submitted by your office via the Alternative Education On-Line Reporting System ([www.aers.state.pa.us](http://www.aers.state.pa.us)) for reimbursement of the grant funds based on the student participation after the grant agreement (contract) has been fully executed by the commonwealth agencies.

Please share a copy of this letter with your program coordinator and business office staff. You should retain a copy of this letter in your files for six years.
