**COURSE DESCRIPTION:**

Students will develop basic reading skills to enable them to attain the highest levels of reading that he or she is capable. Students will progress at their individual ability levels. This class provides additional instruction in the basic reading skills for students who are unable to demonstrate skills at a proficient level. Students must meet placement test requirements and prerequisites to participate in this course.

**Outline of Content Sequence and Recommended Time:**

Individual progression, pace according to the ability level in reading

**Specific Educational Objectives to be Taught:****Assessment Anchors R11****R11A.1 Demonstrate the ability to understand and interpret fiction text, including short story; novel excerpt; and poetry, including sonnet and epic, appropriate to grade level.**
