In the event of renewal, charges will be based on the total student enrollment as of the renewal date. The User Agreement will be renewed yearly on July 1st unless terminated by either party as contained herein.

Either party reserves the right to terminate this agreement and eliminate associated passwords including student accounts with 30 days written notice. Information provided by the school district or school including but not limited to phone lists and data files will remain the exclusive property of the customer. Global Connect agrees not to rent, sell, loan or provide this information to any person or company without written permission by the customer.

In no event shall either party be liable for any incidental, special, consequential or punitive damages including loss of use, profits, revenue or goodwill. Total liability for either party shall be limited to the amount of payment for product or services received from customer during the calendar year such liability arose. Neither party shall be liable for any failure of performance due to causes or circumstances beyond that party's reasonable control. Nor shall Global Connect be liable for any act or omission of any other person or company furnishing any portion of a product or service.

The parties will indemnify and defend each other from and against any and all losses, liability, damages and expense, including the fees and expenses of counsel, caused by any third party claims arising from information, data, or messages transmitted over Global Connect's broadcasting network by a school district or schools located within the district.
