COURSE DESCRIPTION

Course Title: Orchestra

Course Number: 00834

Course Prerequisites: Previous musical experience, preferred

Course Description: (Include “no final exam” or “final exam required”)

Orchestra is a course in advanced instrumental music techniques that meets one period each day. The course is open to all students in grades 9-12 who have level appropriate performance skills on an instrument (string, brass, woodwind, or percussion) and have a desire to improve these skills both individually and in an ensemble setting. In smaller programs the 7th and 8th grade students will combine with the senior high school orchestra.

Orchestra will present at least two performances per year. All performances will be scheduled and placed in the school calendar. Concerts are mandatory and will be part of the course grade. Absence from these performances will be allowed at the director’s discretion.

The course places emphasis on personal improvement in instrumental music skills, and a performance schedule that provides opportunities for demonstration of the level of mastery achieved by the students. A final exam is required.
