The program provides financial support to students enrolled in a PA Department of Education approved teacher preparation program and who are completing their student teaching requirements.

The three (3) WCSD student teachers are receiving PHEAA funding of \$10,000 each.

The program will be held at 4 sites and will focus on homework assistance/tutoring, math and reading remediation/enrichment, STEAM, Environmental Literacy, Cooking, Social-Emotional Learning (SEL), and Career Exploration/Readiness. Summer programming will take place at Beaty Warren Middle School.

As with previous cohorts, slots will be available for students at St. Joseph School. Tidoute Community Charter School has opted out of participating in Cohort 12A.
