Dr. J. Hugh Dwyer has assumed responsibility for all of Dr. John Sechriest's areas with different administrators and others taking the lead or assisting with areas, projects and assignments. Dr. Dwyer will continue to be responsible for the administrative areas that he has had in the Superintendents' Office.

Secretaries Lisa Niedzialek and Kathy Knupp, who were Dr. Sechriest's secretaries, will continue supporting the same administrative areas.

Rosemarie Green has assumed the District Special Education leadership role with Sandy Wilks continuing as Lead SE Supervisor. She is also responsible for the Tutoring Program, ACT, aides, Chapter 15, Classroom Plus, IU5 Curriculum Liaison, Gifted Support Program, Charter School Liaison and her previously assigned areas.

Mark Eberl has assumed responsibility for Athletics and Co-Curricular administration with Jack Werner's assistance and for 2007-2008 staffing with Rosemarie Green's and Amy Stewart's assistance. He will continue with his responsibilities of Human Resources.

Amy Stewart has assumed responsibility for Guidance, Nurses and student health/accident reports, ACCESS funding, student data analysis, student assessment (PSSA, etc.), PDE District Report Card, enrollment projections, membership, IMT leadership and her previously assigned areas.
