

AUTHORIZING THE APPLICATION FOR
COOPERATIVE SPONSORSHIP OF SPORTS BETWEEN
Warren Area High School/Warren County Christian School

WHEREAS, the Board of Directors of the Warren County School District recognizes the value of a program of interscholastic athletics as an integral part of the total school experience to all students of the District, and to the community; and

WHEREAS, the enrollment of **Warren County Christian School** is insufficient to sponsor and compete in the sport of football, and

WHEREAS, cooperative sponsorship would permit interested and eligible **Warren County Christian School** athletes to compete in the aforementioned sports at **Warren Area High School**, yet continuing their student status at **Warren County Christian School**, thus enlarging the scope of their high school experience.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Warren County School District as follows:

1. Introduction and Purpose:

That the Administration of the Warren County School District is hereby authorized and directed to make the appropriate application for cooperative sponsorship to the Pennsylvania Interscholastic Athletic Association and to take all the proper steps that are necessary to provide interscholastic athletic competition at **Warren Area High School** available to interested and eligible **Warren County Christian School** students for the sport that is not currently available at Warren County Christian School.

2. Timeline for Implementation:

The sponsorship begins in the school year 2009-2010. The timeline for implementation is as follows:

- a. Spring 2009 - Students at Warren County Christian School will be informed of the opportunity to participate in the football program at Warren Area High School. Parents and guardians will also be informed of this opportunity.

- b. Summer 2009 – Students and parents/guardians of Warren Area High School students will be informed that students from Warren County Christian School will be participating in football at Warren Area High School beginning August 2009.
- c. Prior to the first practice, August 2009 – All interested students receive physicals from physicians.
- d. August 17, 2009 – First day of practice.
- e. November 2009 – The personnel at Warren Area High School and Warren County Christian School will evaluate the program. A report will be given to the Supervisor of District-Wide Athletics and Co-Curricular Activities, Warren County School District.

*3. Administrative Responsibility, Liability, and Insurance:

- a. The administrative responsibilities for the cooperative sports programs between Warren Area High School and Warren County Christian School shall remain with the Warren County School District.
- b. Liability and insurance coverage for cooperative program shall be the responsibility of the Warren County School District and shall be at the same level as other athletic programs administered by the Warren County School District.
- c. Liability and insurance coverage are to remain the sole responsibility of the Warren County School District.

4. Team Name and Uniforms:

The uniforms will be from Warren Area High School and the name will be the Warren "Dragons".

5. Financial Arrangements:

The program will be supported by the Warren County School District athletic budget approved by the Warren County School District Board of Directors.

6. Staffing:

Coaches selected and approved by the Warren County School District Board of Directors will staff the program.

7. Operation Procedures:

The principal of Warren Area High School will administer the program.

8. Facilities:

Football games and practices are held at War Memorial Field.

9. Transportation:

The Warren County School District will have the responsibility of transporting the teams to away scrimmages and matches and to district and state competitions. Student transportation from Warren County Christian School to Warren Area High School and the return trip will be the responsibility of the participant's parents.




