Dear Mr. Kennerknecht,

I am writing you with regard to the playground equipment located at the North Warren Elementary School. Today's Warren Times Observer states that the school board will discuss the future of this playground at its June 20th meeting.

This letter will remind the District that the North Warren equipment was purchased and installed with the funds and work provided by the North Warren PTO. No funds of the Warren County School District were used.

At the time the equipment was installed the terms of the gift of the equipment were set forth in a letter from the North Warren Elementary PTO to the School District dated September 3, 1999. A copy of that letter is enclosed.

You will note that upon the sale or closing of the North Warren School, the equipment does not become the property of the School District. Rather the equipment passes to Conewango Township or such other municipality or charitable organization that the PTO designates.

I am quite sure that the North Warren PTO will want this equipment to stay in North Warren to be available for the children of the donating community. So please bring this to the attention of the board at its meeting of June 20th, 2005.


Dear Board Members:

I am writing you on behalf of North Warren Elementary Parent/Teacher's Organization with reference to playground equipment that will shortly be erected and installed upon the playground of the North Warren Elementary School in North Warren, Pennsylvania.

This equipment is being donated by the North Warren Elementary P.T.O. for use at the school in North Warren. Because there has been much discussion about the possibility of closing the school it should be made clear that the equipment is to remain located in North Warren if the school is abandoned or closed. If the school is closed and the School District does not wish to maintain the playground at that location then the equipment will revert to the ownership of Conewango Township, or in default of the Township's acceptance to such other municipality or charitable organization as the North Warren Elementary P.T.O. will then designate.
