## SERVICE AGREEMENT

New Opportunities Employee Assistance Program, LP (hereinafter referred to as "Employee Assistance Program"), a Limited Partnership between Stairways Behavioral Health and Deerfield Behavioral Health, Inc., agrees to provide the following contractual services to <a href="https://www.warenewers.com/warenew

- Employee Assistance Program services will be provided to <u>WARREN COUNTY SCHOOL DISTRICT</u>, its board members, employees and members of their household. Appropriate professionals will be provided by the Employee Assistance Program. The service professionals will remain employees of the Employee Assistance Program and shall assume all responsibilities for the liability and quality of these services.
- 2. Employee Assistance Program professionals will be available for both on-site and off-site services. On-site services will be provided as warranted and coordinated through the company representative. Attempts will be made to schedule all appointments in a timely manner. However, immediate crisis situations may be directed to an available and appropriate hospital emergency service. The cost of these services shall then become the responsibility of the referent.
- 3. A limit of three (3) contact evaluation/counseling sessions per occurrence will be available to the Employee Assistance Program client as an extension of the WARREN COUNTY SCHOOL DISTRICT health benefit program. A client requiring extensive services will be referred to an appropriate community treatment facility or provider. The cost of treatment by these professionals will then become the responsibility of the referent.
- 4. Employee Assistance Program services will be provided under the per capita fee schedule based on a non-profit fee of \$1029.60 per month to include Employee Assistance Program evaluation, counseling and consultation services, critical incident stress debriefing and up to three (3) hours of training and education per year. If at any time the employee population of WARREN COUNTY SCHOOL DISTRICT is less than twenty-six (26), the services will be provided under the small business fee schedule based on a non-profit fee of \$475.00 per year to include Employee Assistance Program evaluation and counseling services and up to three (3) hours of training and education per year. The number of covered employees will be verified with WARREN COUNTY SCHOOL DISTRICT within fourteen (14) days of the annual renewal date by a representative of the Employee Assistance Program.
- Additional services may be requested and will be provided based on the following fee-for-service non-profit fee schedule:

Training/Education \$95.00 per hour Critical Incident Stress Debriefing \$95.00 per hour Consultation \$71.25 per hour

Department of Transportation Substance Abuse Professional

Policy Development \$60.00 per hour Supervisory Training \$150.00 per hour Evaluation \$100.00 per hour Follow-up Sessions \$80.00 per hour Urine Screen \$50.00 per hour

Fees for services not listed on the Fee Schedule will be determined at the time of the request.

6. All services of the Employee Assistance Program will be payable monthly.

   <u>DISTRICT</u>, its board members, employees and members of their household are the property of the Employee
   Assistance Program.
- 8. The Service Agreement is in effect on <u>August 1, 2005</u> and will renew annually on <u>August 1</u>. Either party may terminate the Service Agreement by giving thirty (30) days written notice, thereof, to the other party. Modifications of the Service Agreement may be accepted when placed in writing and signed by a representative of both parties.
