It has become evident that a pressing issue needing to be addressed is the assignment of administrative staff. This has been echoed by Board members, Central Office administration, as well as, anxious building administrators. I am aware the Board had reservations regarding the recommendations that former Superintendent John Grant made several weeks ago. In an attempt to address District needs, new and existing building administration experiences and skills, and sensitivity to what I believe may be concerns of the Board the following was taken into consideration:

- reducing the number of administrative transfers to four instead of the original seven;
- assuring the vast majority of the students will have familiar administrative faces welcoming them the first day of school;
- matching new and existing administrators' to compliment their skills, education, and professional experiences to meet the needs of the children, faculty and building programs;
- providing a broader base of experiences for administrators that have potential beyond current assignments;
- providing the potential for further advancement of administrators by broadening essential experiences and increasing retention of administrators; and
- effective, efficient utilization of financial resources by limiting the new administrators to 220 day contracts versus 260 day contracts of their predecessors.

I submit for your perusal the following administrative assignments for 2006-2007 school year, which would effectively become effective August 1, 2006, with the exception of the Youngsville Elementary administrator as noted below:
