AVES	Fulgenzi	Yes	“Yes, I like the direct contact with Marty and Mike Roney. They have been very accommodating and always work with me cooperatively as much as possible. Just their filling in and calling substitutes for the absentees has taken a great load of responsibility from me as the building administrator.”
BWMS	Weber	Yes	“I have been very happy with the custodial situation here at Beaty. We have very quick response whenever a problem arises and have had great support. The custodians have done a nice job.”
EMHS	Martin	Yes	“Yes I would recommend Aramark’s custodial contract be renewed. During my three years at Eisenhower the school has never been cleaner then right now. Matt Swanson is an excellent custodial supervisor. He works very hard everyday to improve the appearance of the building. He remains visible in the building every day and looks for ways to improve the school. He instantly incorporates any suggestions I share with him. He remains flexible and modifies his schedule to meet our needs. Matt is pleasant, and amicable at all times. He is an excellent role model for his employees. In turn the custodians have never worked harder, and been more pleasant than now.”

We have unique needs due to the age of our students and the constant parent traffic. Aramark tries hard and I would say it should be renewed BUT SSEL needs more hours. Bathrooms are not cleaned well nor are the desks because of a lack of hours. When we had someone here for an hour or two between AM and PM kdg, things were cleaner.”
SGES	Madigan	Yes	“Yes, I would recommend the contract be renewed for the 2007-2008 school year for the Aramark’s Custodial Services. The SGES has been well maintained and cleaned through out the school year. I have been very satisfied . . . I do feel things would run more smoothly if additional training and thought went into the changes before they happened. I know the number one complaint from my cafeteria and custodial workers is that there is no one available to answer their questions immediately.”
WAEC	Nelson	Yes	“Absolutely! They provide excellent management supervision of the WCSD staff. I have worked with both Aramark and prior to Aramark, and our schools are cleaner and better maintained under Aramark. I observe a respect for the Aramark custodian by the WCSD custodians. I was under the impression that they would ask for principal feedback. This did not occur during the semester evaluations. 2. Principals should have input on the change of head custodians in their building. During my three years at YHS I have had 4 head custodians and no input in why they were changed. I was told by Mr. Rooney that Mike Madigan was returned to WAHS because he was “fixed” and should return to WAHS. Aramark may have the ability to move people but communication should occur with the principal.”
