## WARREN COUNTY BLENDED CYBER SCHOOL PROGRAM (BCSP)

The Warren County School District Blended Cyber School Program (BCSP) is an alternate rigorous pathway to graduation from the District for students in grade 9-12. Students are required to take at least one traditional, at-school course each school year and to meet the WCSD requirements for graduation. Other courses are taken at home online using computer equipment provided by the District. There is no fee for the WCSD BCSP. Students and parents, who drop-out of cyber courses after 20 school days, will be required to pay for the dropped courses. BCSP students have an individual academic progress plan established by the District with input from the home school, student and parents. On-line courses are matched to WCSD courses and can be selected from vendors approved by the District. Qualified seniors may take Advanced Placement (AP) on-line courses. All on-line courses are rigorous. On-line students must be strong independent workers with excellent attendance records. The District expects BCSP students to be on-line several hours each school day and to meet the completion deadlines established by the District. The District requires parents to closely monitor their children's on-line work and attendance. BCSP students are encouraged to participate in a District cyber student peer group and to participate in co-curricular activities and other school events.
