Executive Summary


Dejong

The Warren County School District has undergone a process to develop a master plan to address all school facilities in the district. The master plan identifies the facility needs in each area of the district and at each existing facility, and prioritizes the order of projects necessary to improve all of the Warren County schools to 21st Century standards. DeJONG, an educational facilities planning firm, was contracted to facilitate the comprehensive process to create a district-wide facilities master plan, and to assist the School Board of Directors make the most appropriate decisions to provide the best education possible for students in Warren County.

The Planning Process began with steering committee formation in June 2008. Comprised of representatives from all areas of the district, the steering committee served as an advisory committee to assist in developing the plan. As depicted, the Facilities Master Plan has been developed with significant community engagement.

The following diagram outlines the planning process.








Background information for the school district was collected to serve as reference material and help guide the planning process. This included demographics, enrollment, student achievement, and facilities data.


Population

The population of Warren County has changed very little in the last 100 years. As the following table indicates, after growing slightly through 1980, the population gradually declined to its current population of just over 30,000 residents.



Historical Enrollment

Student enrollment in the Warren County School District has been declining over the last ten years, consistent with the decrease in population over the last 17 years.








Projected Enrollment

Enrollment over the next ten years is projected to decline as depicted in the table and chart to the right.

Current enrollment in the lower grades (K-8) is significantly lower than enrollment in the upper grades (9-12), and as these students progress through the grade levels, enrollment will at first decline more sharply, and then begin to level out.

Community Meetings

Community meetings were held to introduce the master planning process and gather community input for the plan. In the evenings of June 10-11, 2008, meetings were held at in each area of the Warren County School District in the cafeterias of each of the high schools.

- Eisenhower MHS (June 10)
- Warren Area HS (June 10) Sheffield Area MHS (June 11)
- Youngsville HS (June 11)



Approximately 120 community members attended the meetings. Representatives

from the school district and DeJONG began each meeting by describing the

master planning process. Community members were then separated into small groups to identify ideas for the master plan based on three questions:

- I. What are the major issues or needs in your area of the school district?
- 2. What are the major issues or needs district-wide?
- 3. What should be the outcome of the Facilities Master Plan?

Each group reported its results to the other attendees. Several common themes developed. Community members stated a desire for the plan to prioritize projects and be implemented by the Board of School Directors. Community sentiment exists that the district has performed studies in the past that were not implemented, and the community expressed a strong desire that the results of this plan be actually be implemented.

Participants also described the need for equity of facilities and equal high school course offerings across the district. They recognized the difficulty due to different sized high schools and the distance between facilities, but suggested alternatives such as scheduling changes and distance learning.

Based on the facility condition and educational adequacy analysis, the school buildings were divided into the following categories.

Categories defined:


- Major Renovation or Replacement- includes creating appropriate learning environments and extensive renovation to bring the building up to current codes and may include an addition or entail building a new school facility. After undergoing a major renovation, an existing building should be comparable to a new building.
- Moderate Renovation/Overcrowding- includes bringing facility up to current codes and could include replacement or upgrades to building components and some minor reconfiguration of interior spaces. Overcrowding is where enrollment exceeds capacity.
- Minor Renovation or No Major Improvements- ongoing maintenance and upkeep to extend the useful life of a building, often budgeted on an annual basis as part of the district's maintenance and operations budget. May include selective upgrades of some systems or building components (i.e. boilers, roofing, flooring, lighting, etc.), or some minor reconfiguration of interior spaces.



Facilities Options

The steering committee worked to develop facility options based on the conditions, educational adequacy, capacity and location of school facilities as well as current and projected enrollment in Warren County School District.

Upon development of the options, the Warren County School District with the help DeJONG conducted a community dialogue to present and gather input on the facilities options.

Community Dialogue

Warren County School District held a community dialogue on September 15, 2008 at St. Joseph Church to discuss options for the facilities master plan. Over 250 people from the community attended and participated in the dialogue. Participants were randomly assigned to tables of 7 to participate in small group work.

The meeting was opened by Superintendent Dr. Robert Terrill, followed by a welcome from Mr. J. F. Lockett, Vice-President of the Board of School Directors.

Ms. Ann Ryan, Co-Chair of the Facilities Master Planning Steering Committee, gave an overview of the planning process, describing the timeline including steering committee meetings, area community meetings, and school tours that all helped to shape the facilities options.

Dr. William DeJong, CEO of DeJONG, described the background information that was collected to assist in the planning process. This included:

- Historical enrollment
- Projected enrollment
- Demographic information
- Facility Conditions

He then described the options for the Warren County School District by area and by school. These options are also outlined in the Options Packet

Following this presentation, the attendees completed individual questionnaires to describe their preferences for the options. Then they worked in small groups to come to a consensus by completing a group questionnaire with the same questions. At the end of the meeting the groups recorded their results on wall charts to display the overall results for the groups. Both the group and individual questionnaires were collected and will be tallied and reported by DeJONG. Additionally, an online questionnaire (including the options packet and background report) was made available for one week so that those who could not attend the community dialogue could still have input into the options. Over 250 additional community members completed the questionnaire online.





Recommendations

Using the information collected throughout the planning process, including the background information, facilities summary report, options packet, and community dialogue results, the steering committee presents its recommendations to address facilities in the Warren County School District.

I. The Steering Committee recognizes the positive efforts of The Warren County Schools have made addressing school facility needs over the past ten years.

Many times the focus of a master plan is poor condition of existing facilities. Even though there are numerous needs in the Warren County schools, there have also been projects which have been completed. These projects provide hope and encouragement that remaining needs can be met. In the past decade the Warren County Schools have completed the following major projects:

- New Warren Area Elementary School [WAEC]
- **Russell Elementary School** renovation and addition
- New Youngsville Elementary/Middle School
- Warren Area Career Center addition

2. The Facility Master Plan Steering Committee recommends the following projects to be included in the Facility Master Plan.

- Eisenhower Middle/High School renovation or replacement
- Sheffield K-I2 addition

- Beaty Middle School renovation
- Sugar Grove Elementary School renovation
- Pleasant Township School renovation
- Warren Area High School renovation

Based on the facility assessment and the input received at the community dialogue, the Steering Committee recommends the projects stated above be included in the Warren County Schools facility master plan.

3. The Steering Committee recommends Eisenhower Middle/High School be renovated or replaced.

The Eisenhower Middle/High School facility is in poor condition. The assessment conducted by DeJONG indicated the building should either receive a major renovation or be replaced. The input received at the community dialogue was also divided between major renovation and replacement. The Eisenhower Middle/High School site is a total of approximately 135 acres with 36 acres on the side of the street where the building currently exists and 99 acres across the street.

Whether there is a new school built or the existing school is renovated, the next step toward implementing the project should be the development of educational specifications. Since both renovation and new construction may be viable options, the following actions are recommended:

A. Develop Educational Specification for the project. Educational specifications would determined the most appropriate types, sizes and quantities of spaces for a future middle/high school



on the Eisenhower site. These specifications would also lay out suggested organization of spaces to create a well functioning middle, high school and shared facilities.

- B. Utilizing the Educational Specification, develop concept diagrams of a possible building renovation program and a possible new school.
- C. Based on A and B above, refine cost estimates of the renovation versus new construction options to determine the most appropriate solution.
- D. Finalize the decision regarding the most appropriate course of action.

4. The Steering Committee recommends that Beaty Middle School be renovated.

Beaty Middle School was constructed in 1929 and has some unique architectural qualities which need to be taken into consideration. At the same time the renovated school needs to embrace 21st Century educational practices which would require significant interior modifications of the building. To further complicate the project, the Beaty site is small and the building itself maybe larger than what is needed to house 500-600 middle school students.

To guide the Beaty project, middle school educational specifications should be developed and the school board should take special care in selecting design professionals that have experience in renovating older historical buildings.

The Board of School Directors might consider utilizing some of the excess space at Beaty Middle School for other district functions.

5. The Steering Committee recommends that Sheffield Elementary and Allegheny Valley Elementary be merged into Sheffield Middle/High School to form a K-12 campus.

The Steering Committee discussed various options for Sheffield Elementary and Allegheny Valley Elementary School. The Steering Committee recognizes the preferred option at the Community Dialogue was to combine Sheffield Elementary and Allegheny Valley Elementary at Allegheny Valley Elementary. However the Steering Committee believes the recommendation to develop the K-12 campus at Sheffield Middle/High School will better serve the east attendance area.

The Board of School Directors might consider utilizing the Allegheny building to house school administrative offices.

6. The Steering Committee recommends that Pleasant Township School be reopened to replace South Street Early Learning Center to house all of the central attendance area PreK-I students.

The current South Street Early Learning Center facility is too small to house all of the PreK through Grade I students that reside in the central attendance area. Two community based planning processes have been held in the past year to address options for addressing this situation. The results of both processes suggest the renovation of Pleasant Township School.

Other options such as using both South Street and Pleasant Township have been considered. However the operating cost of running two schools would be greater than operating a single facility.

If the South Street facility no longer houses regular education programs, the Board of School Directors might consider converting this building to district offices.

7. The Steering Committee offers the following recommendation regarding the prioritization of projects.

Phase I

Eisenhower Middle/High School South Street/Pleasant Township School Phase II Sheffield K-12 Beaty Middle School Phase III Sugar Grove Elementary School Warren Area High School

It is suggested the projects be phased in during the next 5-10 years.

8. The Steering Committee recommends that school facilities not recommended for renovation or replacement continue to be properly maintained and kept in proper working order through on-going maintenance and other improvements.

The Steering Committee recognizes that schools which are not recommended for renovation or replacement will also need to be kept in proper working order. These buildings will require replacement of systems such as roofs, windows, paving, airconditioning, electrical upgrades, as well as health and safety items

9. The Steering Committee recommend the Board of School Directors authorize the administration to seek professional services needed to further refine and implement this plan.

To implement this plan, planners, architects and engineers will need to be hired, as well as financial and other consultants. The Board of School Directors is advised to authorize the selection and contracting with appropriate firms to address the projects identified phase of projects.

10. The Steering Committee recommends the District update this plan every five years.


The Steering Committee recognizes the need for the District to keep current; it is suggested that the Plan be updated every five years.

As future decisions need to be made and as projects are designed and implemented, ongoing community involvement should be encouraged. Ongoing communication that builds trust and support for this plan will be important. The Facility Master Plan Steering Committee also stands ready to be of further assistance if needed.




Map of School Facilities

II. Planning Process & Timeline



The facility master planning process is to be developed with extensive community involvement, and focused on developing a facility plan that will meet the school facility needs for the 21st Century.

- 1. **Steering Committee Formation** Comprised of representatives from all areas of the district, will serve as an advisory committee to assist in developing the plan
- 2. School Tours Walkthroughs of all facilities to review building conditions and overall needs
- 3. **Community Meetings** Four community meetings will be held to gain input from the community regarding school facilities in each area of the district
- 4. **Background Report** Facilities data will be collected, analyzed, and summarized into a background report for planning purposes
- 5. **Enrollment Projections** Historical enrollment and previous enrollment projection reports will be reviewed, and new 10-year enrollment projections for the district will be created
- 6. **Options Work Sessions** Based on data collected, review of existing facilities, and input from area community meetings, facility options will be developed
- 7. **District-wide Community Dialogue** Facility options will be presented to the community for input and to help determine the preferred options and establish priorities
- 8. Draft Plan and Recommendations The overall plan and recommendations will be drafted
- 9. Presentation to Board of School Directors Review of the facility master plan
- 10. Board of School Directors Approval Action should be taken on the facility master plan
- 11. Implementation Upon completion and approval of the facility master plan

III. Demographics

General Demographics

The table to the right shows the general demographics of Warren County compared to the United States.

The current population for Warren County is estimated at just below 41,000 by the U.S. Census. Forty-nine percent of the population is male, and 51% is female. The median age in Warren County is 40.5 years old, which is five years older than the U.S. average. Nearly 76% of the population is over 18 years and over, and 16.7% of the population is 65 years and over.

The average household size in Warren County is 2.42, which is smaller than the U.S. average of 2.59. The average family size in Warren County is 2.93, which also is smaller than the U.S. average of 3.14. As defined by the U.S. Census, a household includes all people who occupy a housing unit as their place of residence, whereas a family is a group of two or more people who reside together and are related by birth, marriage, or adoption. Both the median household income and median family income are lower in Warren County than the national average.

Approximately 85% of the population 25 years and over is a high school graduate. Fourteen percent of the population 25 years and over has a bachelor's degree or higher. Compared to the national average, fewer families and individuals are below the poverty level. The median value of an owner-occupied home in Warren County is \$64,300, which is almost half the national average value of \$119,600.








Employment/Economic Characteristics





Population Change

The following table and charts describe the population change of Warren County and the Commonwealth of Pennsylvania from 1900 to 2007.

Population in Warren County has had very little change over the last 100 years. According to the U.S. Census, in 1900 the population of the county was 38,946. In 2007, the population was estimated to be 40,986, only 2,040 more people than in 1900. Warren County experienced a gradual increase in population through the 1900's, and peaked in 1970 with 47,682 people. In the last 37 years, the population has declined by nearly 7,000 residents.

In contrast, the Commonwealth of Pennsylvania has grown dramatically over the last 100 years. Pennsylvania has increased by over 6 million residents in that timeframe. Since 1990, Pennsylvania has increased by 551,149 residents.




I. Projected Enrollment

Live Birth and Building Permit Data

Enrollment is projected using a modified cohort survival method, which recognizes the historical trends of students moving from one grade to the next, and also factors outside influences such as live births and building permits in the school district. An increase in live births may result in an increase in Kindergarten students five years later. Also, increased development may bring new families to the district and increase enrollment. Other regional information may be taken into consideration in the modified cohort survival method, including anticipated changes in economic conditions.

In Warren County, residential building permits have been stable since 1991, with the exception of a large increase in 2004. Live births have been declining since 1991, although in the last 4 years they have been relatively stable, with a small amount of growth from 2005 to 2006.


Projected Enrollment






II. Student Achievement Summary

The following table describes student achievement in the Warren County School District. Students in the district have exceeded the state targets for mathematics and reading proficiency on state assessment tests. Seventy-one percent of students are proficient in mathematics, and 68% of students are proficient in reading.

The graduation rate for the district is 88%, which is the same as the average for Pennsylvania. Of the 425 graduates from the 2006-07 school year, 58% continued their education at a 2- or 4-year college or university, 6% entered a specialized associate's degree program, 5% entered a non-degree granting postsecondary program, and the remaining 31% did not enter postsecondary education. This data indicates that while the strongest need in the Warren County School District is for college preparatory coursework, a significant need also exists for preparation to enter the workforce directly after high school.

III. Community Meetings Summary

Introduction

Dejong

Community meetings were held to introduce the master planning process and gather community input for the plan. In the evenings of June 10-11, 2008, meetings were held at in each area of the Warren County School District in the cafeterias of each of the high schools.

- Eisenhower MHS (June 10)
- Warren Area HS (June 10) Sheffield Area MHS (June 11)
- Youngsville HS (June 11)

Approximately 120 community members attended the meetings. Representatives from the school district and DeJONG began each meeting by describing the

master planning process. Community members were then separated into small groups to identify ideas for the master plan based on three questions:

- I. What are the major issues or needs in your area of the school district?
- 2. What are the major issues or needs district-wide?
- 3. What should be the outcome of the Facilities Master Plan?

Each group reported its results to the other attendees. Several common themes developed. Community members stated a desire for the plan to prioritize projects and be implemented by the Board of School Directors. Community sentiment exists that the district has performed studies in the past that were not implemented, and the community expressed a strong desire that the results of this plan be actually be implemented.

Participants also described the need for equity of facilities and equal high school course offerings across the district. They recognized the difficulty due to different sized high schools and the distance between facilities, but suggested alternatives such as scheduling changes and distance learning.





Eisenhower Middle/High School Meeting

Participants identified the issues in the Eisenhower area to be lack of trust, transportation, energy, technology, need for renovation or replacement of Eisenhower MS/HS and Sugar Grove Elementary Schools, community support, and maintenance of current facilities.

The district-wide issues identified were: consideration of adding Pre-K programs in the near future, the size of the district, availability of course offerings, community, and transportation.

The desired outcomes of the plan are the improvement of Eisenhower, prioritization of all facilities, better collaboration among schools, more technology access and usage, and upgrades to athletic facilities.

Warren Area High School Meeting

In the Warren area, participants identified the lack of capacity for Kindergarten/Ist Grade Students at South Street, the current conditions of Beaty Middle School and Warren Area High School were raised as major issues. Concern was expressed that the career center could be better utilized by the entire district.

The district-wide issues identified were: class size, differing grade configurations, size of the district, staffing, security, and technology and community apathy.

As the desired outcome of the plan, participants would like to see more equality across the district, implementation of the plan, creative facilities solutions, flexibility, and a county-wide vision for the district.



Sheffield Middle/High School Meeting

Participants identified the issues in the Sheffield area as enrollment, attendance area boundaries (including the overlap with the central attendance area at the elementary level), maintenance/condition of existing facilities, keeping students close to home, and educational program opportunities.

The district-wide issues identified were concerns regarding equality of electives, keeping all current high schools open, keeping taxes down, inconsistent grade configuration, flexibility of buildings, transportation, the role of sports in education, and the condition of facilities in other areas of the district, especially Beaty Middle School.



The desired outcome of the plan, participants felt the plan should meet and exceed the educational needs of students. Also suggested was to include a plan for facility maintenance, consideration of the financial impact on community, create and implement a timeline, and unify the county.

Youngsville High School Meeting

In the Youngsville area, participants identified the major issues as technology, maintenance, increasing course options, transportation, and grade configuration.

The District-wide issues identified were: developing a consistent middle school concept, economic development, transportation distances and costs, full-time school health care services, special needs programs, and fewer studies.

The desired outcome of the plan should be a timeline of projects, more distance learning, reduction in travel time, good utilization of tax dollars, and the plan should be realistic and eventually completed.









Site Plan







Based on the facility condition and educational adequacy analysis, the school buildings were divided into the following categories.

Categories defined:

- Major Renovation or Replacement- includes creating appropriate learning environments and extensive renovation to bring the building up to current codes and may include an addition or entail building a new school facility. After undergoing a major renovation, an existing building should be comparable to a new building.
- Moderate Renovation/Overcrowding- includes bringing facility up to current codes and could include replacement or upgrades to building components and some minor reconfiguration of interior spaces. Overcrowding is where enrollment exceeds capacity.
- Minor Renovation or No Major Improvements- ongoing maintenance and upkeep to extend the useful life of a building, often budgeted on an annual basis as part of the district's maintenance and operations budget. May include selective upgrades of some systems or building components (i.e. boilers, roofing, flooring, lighting, etc.), or some minor reconfiguration of interior spaces.



Planning Assumptions

The following planning assumptions were used to estimate the costs of facilities options. The table below represents total project cost estimates for new or renovation of school buildings in the Warren County School District. Please note that these are only planning estimates based on projected 2008 costs and are being used for comparative purposes only. Once a project is selected and designed more precise estimates can be determined. These costs include approximately 20% for soft costs for design fees, contingencies, furniture/equipment, etc. The costs do NOT include purchase of sites, sale of existing properties, or demolition costs of schools if they are to be replaced.

Funding School Construction Projects

Funding school facility projects in the State of Pennsylvania is complicated. New schools and renovation projects are funding through a combination of State and Local funds. Approximately 30% of the costs are paid by the State and the remainder is paid by the local district. The local district share is paid by property taxes.

New schools and renovation projects are typically paid by selling bonds. Bonds are similar to a home mortgage where you pay back the principal and interest over a 25-30 year period of time. The tax impact of a bond issue will depend on the amount borrowed, interest rate, the tax value of property in Warren County and the number of years the bonds are to be paid off.

The property in Warren County is assessed at 50% of market value for tax purposes. In other words, if you own a \$100,000 home it is likely to be assessed at \$50,000 for tax purposes. The total assesses

value of property in Warren County for tax purposes is \$458,198,491.

Typically when financing school construction projects other factors need to be taken into consideration such as existing outstanding debt payment and revenues which are being collected.

Currently the district receives funds for capital projects annually. If those funds were used toward the local share of bond projects, the district could raise approximately \$80m toward a bond issue without raising taxes. This would depend on the phasing of projects, interest rates, and the length of bond issue(s).

Other scenarios would suggest it may require on mill to raise \$80m. A one mill increase on a house with a \$100,000 market value would be approximately \$50.00 per year.

Youngsville High School Options

This building was renovated/expanded in the 1980's. Even though it is rated as a Moderate Renovation it is not anticipated that significant renovation would occur to this building for another 10 years.



Overall High School Options

Currently there are approximately 2,000 students in grades 9-12. It is projected in ten years that this number will decline to approximately 1,500 students. Currently the Warren County Schools operates four high school programs plus the Career center. Two of these schools are middle/high schools [Eisenhower and Sheffield].

No one likes to discuss discontinuing or closing a high school, however, there needs to be a discussion regarding the number of high schools there should be in Warren County when there are 1,500 students. For example, if there were 900 students at Warren Area High School, some of the other high schools would have 200 or fewer students. Many people have expressed concern about program offerings and equity in programs and facilities. Realistically it is difficult to provide a comprehensive educational program and facilities for 200 students.

Other High School Ideas

At the June community meetings, concerns were expressed regarding program and facility equity amongst the high schools. Currently there are approximately 2,000 students in grades 9-12. It is projected in ten years that this number will decline to approximately 1,500 students. Currently the Warren County Schools operates four high school programs that vary in size, plus the Career center. Two of these schools are middle/high schools [Eisenhower and Sheffield]

With limited enrollment it is financially prohibitive to have all facilities and all programs at every high school. At the same time there may be some opportunities through advances in Technology and in changes in program delivery. As technology advances there are likely to be more and more opportunities for On-line courses and Distance learning.

On-line Courses

On-line courses allow students to take courses at high schools, colleges and universities through desktop applications which can be from a school, from home or other locations. As technology advances, it is likely that this will become more and more common. It is already common place at the university level. This may provide situations where there is limited enrollment, such as AP classes, for courses still to be offered.


Distance Learning

Distance learning allows a teacher in one location to simultaneously teach students in multiple locations. This will limit the travel requirements but expand the program opportunities in schools which have limited enrollment.

Thematic Schools

An entirely new idea would be to have "thematic" high schools, where each high school has a specific focus. For example, each high school might have a focus on areas such as science & health, pre-engineering, technology, performing arts or other themes. The schedule might be altered where all students attend their base school for core academic classes on every other day and on alternate days students attend the high school of their choice based on specific programs offered. Thus no all schools would have every program but all students would have the opportunity to have access to a wide array of programs.

Overview/Introduction

Warren County School District held a community dialogue on September 15, 2008 at St. Joseph Church to discuss options for the facilities master plan. Over 250 people from the community attended and participated in the dialogue. Participants were randomly assigned to tables of 7 to participate in small group work.

The meeting was opened by Superintendent Dr. Robert Terrill, followed by a welcome from Mr. J. F. Lockett, Vice-President of the Board of School Directors.

Ms. Ann Ryan, Co-Chair of the Facilities Master Planning Steering Committee, gave an overview of the planning process, describing the timeline including steering committee meetings, area community meetings, and school tours that all helped to shape the facilities options.

Dr. William DeJong, CEO of DeJONG, described the background information that was collected to assist in the planning process. This included:

- Historical enrollment
- Projected enrollment
- Demographic information
- Facility Conditions

He then described the options for the Warren County School District by area and by school. These options are also outlined in the Options Packet.

Following this presentation, the attendees completed individual questionnaires to describe their preferences for the options. Then they worked in small groups to come to a consensus by completing a group questionnaire with the same questions. At the end of the meeting the groups recorded their results on wall charts to display the overall results for the groups. Both the group and individual questionnaires were collected and analyzed by DeJONG. Additionally, an online questionnaire (including the options packet and background report) was made available for one week so that those who could not attend the community dialogue could still have input into the options. Over 250 additional community members completed the questionnaire online.

This report contains the results and analysis of the community dialogue for the Warren County School District Facilities Master Plan.



Community Dialogue Results

East Area Options

The individual, web, and group responses all determined Option B, Using Allegheny Valley Elementary School and discontinuing Sheffield Elementary School, as the most desirable option. Seventy-one percent of individual respondents, and 78% of group respondents selected this option, as well as 47% of web respondents.

Building a new elementary school on the Sheffield MS/HS site or renovating Sheffield ES and using both Sheffield ES and Allegheny Valley ES were both viewed as less desirable.






Warren Area High School Option



Sheffield Elementary is a wonderful elementary school where we have nice class sizes and we are not crammed into one building. I think we have enough students to continue running this school as its own elementary school.
- COST is important in new construction, and the architecture is extremely important. A new building could be constructed and its design could result in increased costs. (eg: high ceilings, open space, no use of "green" ideas such as sun)
- Obviously, the least desirable option is sending the kids from Sheffield and Clarendon to Warren.
- Option D: Use current facilities at SAMHS for elementary students. It does not make sense to continue operating Sheffield Elem. when they could easily go to AV which is a much nicer facility. Absolutely not in favor of any renovations costing millions for 140 students.
- For many area students, it is enough of a long haul to get to Sheffield Elementary School. To put children on a bus for over 1/2 hour to get to school is just too long for elementary age students; it is dangerous for the students and the driver, not to mention a huge waste of gas.
- Allegheny Valley is a beautiful student/academic friendly facility. There seems to be a lot of land to add on or improve the site at some point way down the road. The classrooms are large to accommodate students' needs. Classrooms are equipped with shelving, cupboards, coat closets that make the area useful to teachers to keep organized. What a great location so close to 600 plus acres of state park land. With the monies saved in leasing for Central Administration Offices it seems the County will make out

more efficient and will not lose in transportation due to the busses are already making trips to the Clarendon areas to bus the High School students in fact it may take less.

- By building a new Elementary site for the A.V. and S.E.S students you will not have as many vacant buildings like the remaining sites in Warren due to the A.V. building being a perfect option for Administration. This seems to be a "no brainer".
- The East Attendance area is the smallest and the only one with two elementary schools still in operation. If the Central attendance area can consolidate all of their schools into one, so can this area.
- I don't feel the closing of Sheffield Elementary will solve the problem. You
 will be spending more in the long run if you close S.E.S on transportation
 costs. I also do not feel Allegheny Valley has the room or is equipped to
 handle 137 more students. What kind of education will these kids get
 (how much one on one time with teachers). You will also be destroying
 the community of Sheffield.
- I feel it would be more convenient for parents from both Clarendon and Sheffield to have their children all in one school.
- Financially, option B is the most logical and responsible. Having had four children who attended SES and SAMHS, there is always a conflict when the students from AV and Sheffield attend school together in grade 6. It would be better if they all attended school together from day one. AV is an updated school that can accommodate the Sheffield Elementary Students. It has never made sense to operate that school at 50% capacity and keep SES operational.
- At a cost savings fo over three million dollars, this is a no brainer, fix our

local elementary school. First of all, why spend any extra money to bus students any further than necessary. It is more of a burdent for any parent to have to pick their child up from a school further from their homes in the event of an emergency, sickness, and/or appointments. Secondly, our kids, at this age level, are easily influenced by that of older children, why start so early? Please, do not expose our local children to learning that negative behavior at such an impressionable age. In fact, I think Warren and Forest counties should be talking about a merger to eliminate some services/ administration. We need to focus on curriculum needs. Just because schools are larger does not mean classrooms have to be larger. I can't believe students travel from Youngsville to take college prep/ AP courses. (waste of TIME and RESOURCES) Students in larger cities are exposed to IB programs. Think of the advantages they have when they begin college. And what about our vocational programs? Should we improve them so students don't have to go to an expensive trade school to obtain employment? Lastly, if nothing else, it is time to merge athletic programs. Some schools can't even field a team, or try to and are destroyed in competition. Some students/ parents seem to think it is an entitlement to make an athletic team.

- I've not lived in the Warren County School District area for some years, but due to the decrease in projected number of students, I find it most efficient for two High Schools. I know I just took the survey stating that they should renovate or build new for most options, but because I was unaware of the projections, I failed to realize the need for some sort of combination. However, I believe that the need for the elementary schools in their current locations remain. Small towns are difficult to combine, and the distances traveled for bus transportation would be increased with some of these changes suggested. The need for more student activities, both educational and sports related would increase with the combination of the Districts four High Schools into two. More competition would arise as well, gaining a more competitive academic and athletic arena, with more options for students wishing to continue their education.
- If high schools are closed, the children will have long bus rides.
 Transportation costs in the end would probably eat up anything you would save by consolidating the high schools.
- If there were to be 3 high schools, it makes the most sense to close Eisenhower, which is said by you to be in need of the most repairs/renovations. Combine Youngsville and Eisenhower since they are close in proximity. Close Beaty. Build a new WAHS that is 7-12.

- Some students have more than one interest and would need a facility that is able to provide them with an excellent education in more than one area. Thematic schools are GREAT, but you have to have the numbers to support them. The cost of keeping 4 high schools open, and then providing transportation to all of them does not make fiscal sense. Specialization can occur without separate physical buildings.
- Online and distance make sense to me only if we maintain several buildings, or if the distance programs include "guest" instructors outside the district. Online will continue to develop at all levels, regardless.
- The thematic focus would require students to travel significant distances to their "theme" school on alternate days; for example, if Sheffield was the center for science, students from Youngsville and Russell attendance areas could potentially be on a bus for more than an hour and a half on those "focus" days. In my opinion, this is not an acceptable option.
- A thematic focus would cause numerous transportation issues. It would also put too much pressure on young teen-agers to decide their focus too early.
- Traveling teachers? Offer the classes at the schools and have teachers travel.
- I think having k-12 campus at each location would be best: Warren Campus, Russell Campus, Youngsville Campus and Sheffield Campus. This way no one looses their sense of community, but I do agree that we need to make all course offerings available at each campus. All of Warren County should have the same opportunities.

- Magnet schools will benefit the highly motivated students. Would one high school continue with a career track rather than a college prep/arts specialization? Does block scheduling core courses at the high school level produce an acceptable educational outcome? Can the computer take the place of "live" teaching? It definitely depends on a student's learning style. In most cases, are they mature enough to handle this?
- There is no equity with all the schools through the County as not every school has the same opportunities. Some students don't even know what is offered through Distance Learning or online courses.
- Students don't want to learn from a screen. They are human beings not computers to be programmed.
- I've spoken with students throughout the years that have had the "distance" learning and they all feel that the course was useless and did not learn. Example: a Warren High student had televised German classes from Eisenhower and did not get the attention and assistance to learn that subject.
- Students change their minds and their focus/career paths constantly. I can envision one student moving from school to school dependent upon their preference of the week OR a student may miss opportunities because the choices are not available at their currentschool.
- Best idea in this survey. Go to Warren County.
- I like the thematic focus idea but it also sounds like a logistic nightmare. Transportation would be an issue. Also, what percentage of the students "know" what specialty they want as a Freshman or Sophomore?
- While I believe there are definite benefits in exploring the distance learning (both online and tele- or video-conference) options, I do not believe that



high school students have broad enough experience to declare a specific "theme" for their high school career. It is our jobs as parents and educators to give them the broadest base of experience possible to allow them to make these decisions prior to college. I believe this is something for which the current system does not provide. For example, college bound juniors & seniors are placed in a "College Prep" curriculum path, which, in my experience, consists of advanced level math & science courses. However, a student choosing to enter a business profession is not prepared for business classes in college. This idea may be outdated, but again, in my experience, the "business prep" students would have been more prepared.

- How many 15-17-year old children have a committed idea as to what they want to do after high school?
- I have made an excellent living developing and selling distance and online learning solutions (albeit in completely different arenas), so my thinking here is not completely uninformed. I appreciate the efficiencies of these approaches and acknowledge some benefits, but at core I am skeptical,

except perhaps as a supplement to a curriculum that is fundamentally traditional in format and delivery.

- As a teacher, I'm supervising an online course. There is very little group discussion because the students are separated and therefore it is not a very dynamic situation. Thematic Schools sounds like a great idea, but just too much cost in the transportation.
- Many of Warren Counties' students ride the bus for an hour each way just trying to get to their home school. Students need more class room time, not wasted time on a bus. I also don't like the idea of worrying about my children riding all over the county every day.
- I take college classes online and i love them but I realize how much you

- Not necessarily, it depends on the size of the school and the amount of students the school can accommodate. If it is a larger school with enough staff to cover the grade levels, then it should remain that way.
- I answer #13 Russell/Sugar Grove, not really knowing the capacity of the school. Each attendance area should be structured to meet the needs of that community. We can be in the same school district but have separate break downs.
- 6th grade students should be in a middle school rather than Elem. or HS. 1 would choose Elem. over sending them to a HS.
- Let them stay in their own communities
- I would like to see 6th grade be brought back to the elementary schools.
 6th graders should not have to be forced deal with the middle school issues.
- If 6th grade is implemented at Eisenhower... Structure like Sheffield does might be most beneficial keeping the 6th grade students in a certain area.
- Sixth graders should ideally be in a true middle school setting, with grades 6-8 in a separate area with separate faculty for core subjects and shared athletic/art/music/cafeteria areas (or a stand-alone middle school building, in Beaty's case).

- 13A Eisenhower should be K-12 including Sugar Grove and Russell elementary schools.

• Sugar Grove school and Eisenhower High School should both REMAIN open. I think going to two schools is a bad idea. My daughter is a school psychologist and she thinks large schools are an invitation for children to get lost in the system. Why would anyone want their fifth grade children put with tweens and/or teen agers? I am afraid doing this would cause more problems with subjecting innocent fifth graders to more hormonal, unpredictable tweens or teens. To me this solution is unacceptable and creates more problems then it's worth.

• I feel it would be a good idea to build the building to accomodate more than the 250 students as listed on the options. Sugar Grove Elementary

already has at least that many students currently, if not more. Why take the chance that Sugar Grove could run out of space, like Russell Elementary and the Warren Elementary Center?? I'm sure the "extra" rooms would be put to good use and turned into classroom space as needed. The students at Sugar Grove currently have to take their art classes on the stage in the cafeteria, while either gym or lunch is occurring on the other side of the curtain, and their music classes in the library. Sugar Grove Elementary is desperately in need of more space in the "cafeteria-gym-all purpose" room!!! When only 1/2 of the school has an event, such as a Christmas music concert, the parents have to arrive over an hour early to even get a seat. I'm sure there are Grandparents and other family members that would love to attend also, but then where would the parents and siblings sit?? We've seen parents crushed in the hallways, way past the restrooms, and they never get to see their children at all. Also, I don't feel it's right to hold gym classes in the cafeteria, where the students don't even get to finish their allotted time, because the cafeteria needs to be "set-up" for lunch periods. In this day and age where physical activity is an absolute must, why should the activities be restricted due to a lack of space?? I also don't understand if the elementary school was moved to an "Eisenhower campus", how would they "share" a gym and a cafeteria??? I'm under the impression that it's already difficult to fit in all the events at Eisenhower, when would the elementary students be scheduled in there? And, would some students have to have their lunch scheduled at 9:30 or 10:00am or at the other end, as late as 2:00pm? It seems like a lot of students to schedule for one room, or is the room going to be "very large"?

- Sugar Grove is in the same situation as Sheffield Elementary. I think it is important that we maintain and renovate these wonderful small buildings that we already have instead of building new buildings in new locations.
- Consolidation would be the least desirable course of action.
- Option D: Send elementary students to Youngsville (with the closing of

EHS). Again, I think it would be beneficial for parents to have the children all in one school.

- Keep the children where they are. Compare the costs and consider the children's best interest in mind. Their education is the basis of their entire life. Do not expose them to any changes that are changes that are not needed. Renovate during the summer.
- Children from Lottsville area should NOT be bussed clear to Eisenhower, that's too far.
- Split Sugar Grove Elementary students between the two existing schools that are currently in good condition (Russell Elementary and Youngsville Elementary.
- I believe the residents of Sugar Grove would best be served by a community school.
- Under no circumstances would I approve of the elementary school being moved. I believe we as citizens in a world without unlimited fuel resources should think of keeping things local in order to conserve. Our US society is unique because we value our rural areas. Please do not attempt to make them like the city. We like our small schools! Our children deserve to go to a school that is not in disrepair.
- Fifth graders are too young for middle school. They are elementary students, and should be in an elementary facility. If you must send more students to WAEC, add on to it to accommodate all grades 1-5.
- Need to decide on high schools first and then "trickle down"
- Where would central attendance area students go from RES- to Beaty at 6th or 7th grade, or would EMHS be reconfigured to 6-12 to accommodate the boundary change?
- Option C is missing.
- I believe that there should be more consistency throughout the district. This is why I would not vote for 5th grade at WAEC to be moved to Beaty. The other elem. schools have their 5th grade students. We have tried 5th at Beaty and we moved them back to an elem. setting. We need



to keep it that way in my opinion and build more consistency to grade level placement.

- With all the money that was spent on the BIG Warren Elementary Center you would've of thought it would've been built to accommodate more students but that was evidently not a well thought through idea. When the Russell Elementary was projected it should've been thought through thoroughly to accommodate students or more thought put into a whole complex on the Eisenhower High School site!
- Seems like we need fresh thinkers making some new sound ideas for our children. Sending our kids to Pleasant Township? Sending fifth graders to Beaty? Just how many vacant schools are their in Warren County?

What should the role of the Warren County School Board be in this process? In my opinion, the school board has dealt with the issue of building deterioration, equality in school offerings, sport programs/facilities, etc. for many, many years. With declining enrollment, it is the responsibility of the school board to create a plan that is fair to the students in the district. At the same time, the board MUST be fair to the taxpayers; the board must not allow the emotional impact of school rivalries and what has been done in the past to affect their decisions. Higher costs that the taxpayers in this district face may mean that some unpopular decisions must be made by the school board. We have had too many school boards in the past be swayed by emotions instead of what is

best for the district as a whole. I can only hope that the current school board has the courage to make decisions that are in the best interests of the students and the taxpayers of this district. (I overheard one student make the statement that the parents are the ones who can't let things go; he said, "Students will adjust, but the parents just won't let the way it has always been go; they are the ones who keep talking about the "rivalries'." That's a pretty observant insight from a young adult!

- Please look at the whole community, not just in town!!!!!
- Why wasn't basic maintenance done on Sugar Grove and Eisenhower when Warren has had work done and so has Youngsville? I think that you have always wanted to bus Sugar Grove students to other schools since it



was consolidated in the sixties when Warren got all the new schools that are obsolete. Consolidating has been a bad thing for the Eisenhower school district.

- If we have to close a High School, what about closing Youngsville and giving them the option to go to Eisenhower or Warren.
- Do you favor equality among all schools? Yes so let's make it happen -For all to long certain outlying schools have taken the back seat and we have let those more affluent citizens sway the direction of the entire district.
- Why are we spending money on surveys and not doing what the people of the Eisenhower attendance area want. Maybe we should take our students out of the Warren District and form our own district again.
- Personal opinions.....I moved to Sugar Grove so my children could go to school at Sugar Grove and EHS. They are all academically doing awesome and are involved in sports. These schools have a "family" atmosphere and this is what I want for my children. I dont want them to become a "number" so to speak.
- When Warren County Warren students didn't have current text books and they built all new schools I think that it is time to think of the Eisenhower district for a change and I'm sure nobody is going to buy Eisenhower High and make it a nursing home. That was the suggestion last time as you can see the other schools have not sold why do you think they would this time. You should have done basic upkeep on the schools. Why wasn't this done?
- I feel that one or two high schools is unreasonable in terms of transportation for children on a daily basis. It will be hard on parents to try to travel these distances daily in terms of sports and extracurricular activities. I feel that two high schools and two middle schools for the Warren County would be sufficient. I feel the middle school should be grade 2 through 9 and high school should be 10 thru 12. The younger children should stay closer to home in the learning centers.

- When the children are sent to the middle school they could be kept separate from the older children. If you are going to change the schools do it right in the first place instead of having to make changes a few years after making the decision.
- Oh, I like this question. I think you need to ask "What is the primary goal of school facilities in Warren County?" And I think the right answer is "To give our children the best possible education and prepare them to take their place in the world as functional adults." I think the practical, current, and wrong answer is "To promote regional, almost tribal, loyalties and rivalries and the 'not in my back yard' selfishness that will destroy our society."
- 'Facilities equity' is too vague there is a HUGE discrepancy between what departments have in different schools! Why should one department have so much and others so little? Why should a subject teacher have to tolerate no classroom, few materials, etc in one building and the same subject teacher have the blessings of an actual room with adequate materials in another building? This absolutely affects student outcome. What administrator is going to put a HIGHEST PRIORITY on this matter? If, as you say, EVERY teacher affects students' success, then why is there such a LOW priority permitted to exist with regard to teaching environments and materials? My colleagues and I HAVE been asking this question and getting NO answers. Which administrator is going to go to bat for ALL of us under her/his supervision? How are we to be EVALUATED fairly if our working conditions are so disparate?
- Thank you.
- How much would be saved by closing Sheffield Elem? A couple years ago it
 was determined that it would save approx. \$240,000. This is very
 insignificant and if you cannot show an improvement in education for my
 kids by moving them to AVES, why would anyone in their right mind
 support this. The children at SES receive an A+ education not because of
 the facility itself but due to the staff, Administrator, parents and community

combined.

- You did not ask how we would feel if our school was closed and our children had to spend an extra hour every morning and afternoon on the bus.
- My answer is: I would not want my child to have to get on the bus at 6 a.m. and not arrive home until 5 p.m. So therefore I and numerous other parents would begin home-schooling our children (we have already discussed this. We are qualified) The enrollment numbers will drop even more than the ridiculously low figures that have been projected.
- We are asking what is best for cost, the students, transportation and having more academic choices, But what are we willing to offer in helping students, teachers and families that need information on learning disabilities, and children who struggle daily with health issues and all the other things in between that life just seems to hand them and everyone involved with these kids. Can a, or is a facility open, or could a facility be open in one of these locations for furthering special education in us all, students, teacher, parents and anyone who works with these situations on a daily basis, open for anyone who wants to better the future in a child. Can the school district supply any of these or is it already available?
- We need to be more involved is teaching, training and raising our children as best and as knowledgeable as we can to better all our facilities, homes and society.
- Regarding Sheffield Elementary closing and going to Allegheny Valley....Sheffield Elementary has every classroom filled. I can't imagine how these children would effectively learn in a crowded atmosphere. I feel that all day Kindergarten is a big change
- for 5 and 6 year olds. You are asking for problems if you plan on tacking on another hour for busing to their already 7 hour day. Tired kids equal sick kids and poor academic performance.
- Are you in favor of splitting the district? Yes, We are not doing what is best for the majority of students (Warren attendance area). If the smaller

areas want to keep their community schools they can pay the higher taxes to keep them open.

- What options provide the best EDUCATIONAL advantages? We seem to be focusing on too many issues like transportation, athletics, etc. instead of what would give our children the best education. If consolidating schools would give students access to advanced classes, better teachers (based on actual learning, not standardized test scores), classes based on ability, more specialized help, etc. then we need to take this option.
- JUST LEAVE SHEFFIELD WERE IT IS !!!!!!!!
- I think boundary lines in the District should be absolute. Students on Route 59 or in North Warren shouldn't have a choice to have transportation to 2 different schools. My children are on the line between Sheffield and AV, but I have to drive them to Sheffield.
- Why was the option of Sheffield and Clarendon Elementary and Sheffield Middle/Senior High School (all combined) at the present high school site listed as an option? Because Clarendon is among the newest built school it could remain open for all day kindergarten for the Warren area as it is now and also house some central office personnel. Seems like a win/win situation.
- Q. How will the quality of education in Warren County be impacted? A. This should be our top priority.
- The incidence of high-risk behaviors and tendency of various social groups to segregate will likely increase with larger student populations. I'm afraid that parent/community involvement and support will be reduced with increased travel distance to the schools.
- Would you consider supporting fundraisers to help offset costs? Yes
- Too much moving of school children will result in more "Charter Schools" in our district !!!
- Are there any other options for building usage that have not been mentioned? If Allegheny Valley is large enough to accommodate all of Sheffield Elementary, then why not use the extra space to house Central





Office (along with the students in the Allegheny Valley attendance area)? Some of the administrative offices are already there.

- Why do we have to spend so much money on studies and task forces over the last fifteen years, when we could have parlayed that money into renovations and closed some schools, and therefore, saved money! I believe that this is a very good way to attack the situation at the schools. I also feel that it is a much better option then the "studies" that co\$t so much.
- Maybe you should ask the students. Has anyone thought to get feedback from those who will be effected the most? It seems that their opinions would be important. I realize that they would not have beneficial input or guidance in terms of financial issues, but it seems that there should be a brief survey performed to the students to at least get their input, and allow them to feel as if their voices are being heard.
- Please do not close Eisenhower. Large schools give less one on one attention with students and teachers.
- Q How many students should there be in a [graduating] class in order to best serve the diverse abilities of the students? A More than currently in Sheffield, Eisenhower, and Youngsville schools. (You probably asked the question with different wording, but the public needs to grasp this idea).
- I was wondering if there were any discussions of adding daycare/preschool programs that supported WCSD's curriculum to any of the buildings? Is there talk of WCSD addressing the need for preschool/daycare that are supported by the district?
- Do you think that the superintendant and administration is worth the salaries they are getting for all the years of mismanagement? Answer: NO, suggestion: their salaries should be cut to cover the cost of taxes snd necessary repairs that should have been being done all along.
- What do you think we can do to better take care of our buildings in the future? The district needs to be more proactive in caring for its buildings. For years, we've watched as buildings have come into a state of disrepair.

If we are going to build new buildings, it is imperative that we take care of them from the beginning. I think you need to look at the industry in Warren county. If Blair adds 200 more jobs people might decide to move back to the area bringing their families with them. If we consolidate schools to much we will run into the same kind of problems that we are currently seeing at South Street. One small change in a curriculum puts the entire county in an uproar. Everyone knew that full day Kindergarten was on the way, this should have been taken into account when the new Elementary Center was put in place. Beatty is a joke, the school is so dark and dirty looking, I am not proud to be sending my child there.

- I think we need to do some serious renovating keeping in mind the future of the county. Projections are killing it off, let's take away a few more schools and really push people out of Warren County. I think we need to take a look at other counties in Pennsylvania and see how many of them have I high school, I'm guessing we will find that this is not an option anywhere.
- question: Would it be wise to spend astronomical amounts of money to build a new north attendance area school(s) when enrollment is projected to decline? answer: NO! Concentrate on splitting those schools into other attendance areas and improve those schools, if necessary.

- I know that this option infuriates families in the Eisenhower area, which
 makes it nearly impossible to have a public dialog considering this option. I
 myself would not publicly anger friends who have students at this school,
 but I think this is the best option. When I was in high school the same
 situation happened in the town I grew up in. The families affected by the
 closure were very angry and vocal. But guess what? In two years it wasn't
 even an issue anymore. People adjusted, high school students who were
 rivals integrated well. It was OK! Also, because my statistical information



will show me living in the WAHS attendance area, I want you to know that I do not have students attending any public school.

- Do students perform better in big class sizes or small class sizes? I would hope that this has been studied as well as the expense part of all these proposed projects. I truly believe that a child learns better in a smaller class size than larger as would probably be the case in the one high school scenario. I believe back in August Newsweek put out a whole issue on school rankings and in what situations (class size, distant teaching, etc.) students excel in. It might be worthwhile in obtaining that article or one similar when making your final master plan. I believe that article stated they were finding after all the years of pushing consolidation that the non consolidation was what they were going back to because the students performed much better in those atmospheres. Something to think about!!!!!
- Obviously I am not for that one high school theory nor do I believe it is the best for this out-stretched county.
- Please understand that most citizens in the Eisenhower attendance area and probably Sheffield and Youngsville as well choose to live in rural areas because of the rural schools, not in spite of them. Part of rural life is small schools. To take away the small schools robs rural citizens of one of the

foundations of their living choices and values. If I wanted my child to attend a bigger school I would not have chosen to live where I do. Community schools are crucial to the health of rural life. And the health of rural life affects everyone in the community and consequently our society at large.

- Are there any ways we can reduce the costs of operating this school district? YES! Reduce or preferably eliminate all mini-van "buses" that are so prevalent on our county roads! If a student has a behavior problem and can't ride the regular bus, or if a student is attending a private school- let them find their own ride to school- PERIOD! Of course this would not apply to the students in our county that are physically challenged. Also, explore options to eliminate uneeded or redundant positions within the Central Office.
- Tell me in detail, how is SES in poor condition? Also, How can you say zero cost to close SES and put the students at AVES ?You would have to build on to AVES to house 280 to 300 students. You would never get all the students in all the classes needed and what about lunch times for all the children? There is a lot more than this to consider.





Recommendations

The Warren County School District Facility Master Plan Steering Committee is pleased to submit the following recommendations.

I. The Steering Committee recognizes the positive efforts of The Warren County Schools have made addressing school facility needs over the past ten years.

Many times the focus of a master plan is poor condition of existing facilities. Even though there are numerous needs in the Warren County schools, there have also been projects which have been completed. These projects provide hope and encouragement that remaining needs can be met. In the past decade the Warren County Schools have completed the following major projects:

- New Warren Area Elementary School [WAEC]
- Russell Elementary School renovation and addition
- New Youngsville Elementary/Middle School
- Warren Area Career Center addition

2. The Facility Master Plan Steering Committee recommends the following projects to be included in the Facility Master Plan.

- Eisenhower Middle/High School renovation or replacement
- Sheffield K-I2 addition

Dejong

- Beaty Middle School renovation
- Sugar Grove Elementary School renovation
- Pleasant Township School renovation
- Warren Area High School renovation

Based on the facility assessment and the input received at the community dialogue, the Steering Committee recommends the projects stated above be included in the Warren County Schools facility master plan.

3. The Steering Committee recommends Eisenhower Middle/High School be renovated or replaced.

The Eisenhower Middle/High School facility is in poor condition. The assessment conducted by DeJONG indicated the building should either receive a major renovation or be replaced. The input received at the community dialogue was also divided between major renovation and replacement. The Eisenhower Middle/High School site is a total of approximately 135 acres with 36 acres on the side of the street where the building currently exists and 99 acres across the street.

Whether there is a new school built or the existing school is renovated, the next step toward implementing the project should be the development of educational specifications. Since both renovation and new construction may be viable options, the following actions are recommended:

- A. Develop Educational Specification for the project. Educational specifications would determined the most appropriate types, sizes and quantities of spaces for a future middle/high school on the Eisenhower site. These specifications would also lay out suggested organization of spaces to create a well functioning middle, high school and shared facilities.
- B. Utilizing the Educational Specification, develop concept diagrams of a possible building renovation program and a possible new school.
- C. Based on A and B above, refine cost estimates of the renovation versus new construction options to determine the most appropriate solution.
- D. Finalize the decision regarding the most appropriate course of action.

4. The Steering Committee recommends that Beaty Middle School be renovated.

Beaty Middle School was constructed in 1929 and has some unique architectural qualities which need to be taken into consideration. At the same time the renovated school needs to embrace 21st Century educational practices which would require significant interior modifications of the building. To further complicate the project, the Beaty site is small and the building itself maybe larger than what is needed to house 500-600 middle school students.

To guide the Beaty project, middle school educational specifications should be developed and the school board should take special care in selecting design professionals that have experience in renovating older historical buildings.

The Board of School Directors might consider utilizing some of the excess space at Beaty Middle School for other district functions.

5. The Steering Committee recommends that Sheffield Elementary and Allegheny Valley Elementary be merged into Sheffield Middle/High School to form a K-I2 campus.

The Steering Committee discussed various options for Sheffield Elementary and Allegheny Valley Elementary School. The Steering Committee recognizes the preferred option at the Community Dialogue was to combine Sheffield Elementary and Allegheny Valley Elementary at Allegheny Valley Elementary. However the Steering Committee believes the recommendation to develop the K-12 campus at Sheffield Middle/High School will better serve the east attendance area.

The Board of School Directors might consider utilizing the Allegheny building to house school administrative offices.

6. The Steering Committee recommends that Pleasant Township School be reopened to replace South Street Early Learning Center to house all of the central attendance area PreK-I students.

The current South Street Early Learning Center facility is too small to house all of the PreK through Grade I students that reside in the central attendance area. Two community based planning processes have been held in the past year to address options for addressing this situation. The results of both processes suggest the renovation of Pleasant Township School.

Other options such as using both South Street and Pleasant Township have been considered. However the operating cost of running two schools would be greater than operating a single facility.

If the South Street facility no longer houses regular education programs, the Board of School Directors might consider converting this building to district offices.

7. The Steering Committee offers the following recommendation regarding the prioritization of projects.

Phase I

Eisenhower Middle/High School South Street/Pleasant Township School Phase II Sheffield K-12 Beaty Middle School Phase III Sugar Grove Elementary School Warren Area High School

It is suggested the projects be phased in during the next 5-10 years.





8. The Steering Committee recommends that school facilities not recommended for renovation or replacement continue to be properly maintained and kept in proper working order through on-going maintenance and other improvements.

The Steering Committee recognizes that schools which are not recommended for renovation or replacement will also need to be kept in proper working order. These buildings will require replacement of systems such as roofs, windows, paving, air-conditioning, electrical upgrades, as well as health and safety items

9. The Steering Committee recommend the Board of School Directors authorize the administration to seek professional services needed to further refine and implement this plan.

To implement this plan, planners, architects and engineers will need to be hired, as well as financial and other consultants. The Board of School Directors is advised to authorize the selection and contracting with appropriate firms to address the projects identified phase of projects.

10. The Steering Committee recommends the District update this plan every five years.

The Steering Committee recognizes the need for the District to keep current; it is suggested that the Plan be updated every five years.

II. The Steering Committee recommends the community be continuously involved in the planning and implementation of these recommendations.

The involvement of the community was important in the development of this plan. As future decisions need to be made and as projects are designed and implemented, ongoing community involvement should be encouraged. Ongoing communication that builds trust and support for this plan will be important. The Facility Master Plan Steering Committee also stands ready to be of further assistance if needed.
