The district submitted a proposal via the 2009-10 PA-PACT to expand the Student Assistance Program (SAP) in the Warren County School District. The expansion requires a Master's level SAP liaison, to be provided by Beacon Light and paid for through the PA-PACT Grant. The PA-PACT was approved the week of August 17, 2009. The administration is seeking permission to add this contracted service to the 2009-10 SAP contract. The 2008-09 contract is attached for your information; the new contract would be identical to the 2008-09 contract, with the addition of the contracted service requested above.

The district is awaiting a draft of the 2009-10 SAP contract from Beacon Light Behavioral Services, which we expect by the September 14th WCSD Board meeting. The contract will be prepared in consultation with district solicitor. Funding: \$58,890 through the 2009-10 PA-PACT Grant.

Action: The committee voted to take this to the regular meeting with language changes.

Suggested motion: That the Board of School Directors amend the contract with Beacon Light Behavioral Health Systems to include the services of a Master's certified SAP liaison. The liaison cost will be funded entirely through the 2009-10 PA-PACT grant award.
