1. Opening Activities

2.01 In Service Training

2.03 Edulog Transportation Routing Software

Discussion. The administration has reviewed Transportation Routing Software to replace the current deployment of Bus Boss. An evaluation committee comprised of members of district administration, building secretaries and bus contractors reviewed several software vendor solutions. Mr. Brian Collopy felt this software will work well for our district and did not feel we will have the problems we have previously had with the Bus Boss software.

Education Logistics has proposed quote on a hosted web based solution with initial startup costs of \$6,495 with a recurring yearly license fee of \$1,435. Service plans are offered at a monthly rate based on our district's needs.

The vendor recommendation is to begin with a Platinum Level Service agreement at a rate of \$550 per month that will cover training and a dedicated full time consultant from Education Systems until district staff is comfortable using the software or until the service plan is reconfigured.

Action: The committee voted unanimously to send this to the full board for approval

Motion: That the Board of School Directors approves the contract for Education Logistics to provide transportation routing software at the initial setup cost of \$6,495 and a month to month Platinum Level Service agreement at \$550.
