ADDENDUM TO LEASE AGREEMENT #1359165 BETWEEN U.S. Bancorp Business Equipment Finance Group, AS OWNER and Warren County School District, as CUSTOMER

This addendum is hereby incorporated into and made to said Lease Agreement between Customer and Owner (attached as 'Exhibit A' hereto). Customer and Owner agree that the above-mentioned Lease Agreement shall be clarified as follows and all other terms and conditions will remain in full force and effect.

Because the Executive Summary sheet from the July 26, 2010 Warren County School District School Board meeting incorrectly lists the 60 month price quote for a 36 month lease term, this addendum hereby clarifies and correctly states that the terms and payments set forth in the executed Lease Agreement and customer issued purchase orders are the terms that were approved by the School Board. The July 26, 2010 School Board approval of the U.S. Bank lease agreement and the price quote from James B Schwab Co. Inc. is hereby clarified to be for a 36 month term at the 36 month term price quotes as signed for by the Board President on July 26, 2010.

By signing this Addendum, Customer acknowledges the above changes to the Agreement and authorizes Owner to make changes. In all other respects, the terms and conditions of the Agreement remain in full force and effect.
