SCOPE OF SERVICES

DeJONG-RICHTER will develop Educational Specifications for the Beaty-Warren Middle School in the Warren County School District. Educational Specifications describe the current and future activities that a school facility should accommodate and provide a written communication from the owner [or educator] to the design professional. They illustrate briefly and clearly the goals and outcomes, activities to be conducted, the persons to be served, spatial relationships of the program areas, equipment needs, technology needs, and special considerations.



The process to develop Educational Specifications for Beaty-Warren will involve the following steps.

Committee Formation

A committee, composed of teachers, administrators, support staff, special services staff, students, central office personnel, and community members is formed to assist in the development of the educational specifications.



Planning Lab #1

Lab #1 is an intensive two-day work session examining future trends and determining program direction. Participants discuss programmatic and space needs and generate a draft report. DeJONG-RICHTER recommends the presence of the district's design team at all planning labs.

Draft Educational Specifications

As a result from input at Planning Lab #1, DeJONG-RICHTER will draft the educational specifications for review at Planning Lab #2.

Planning Lab #2

Planning lab #2 is another intensive, two-day work session to further edit and refine the draft program & design requirements. This lab incorporates large group work, as well as smaller, breakout group work. Participants resolve space requirements and begin to conceptualize the facility.



Final Report

A final report is completed and presented to the Board of Education for review. It contains results of the orientation and visioning session, a compilation of space, program illustrations, and spatial relationship diagrams for each classroom and the entire facility.



Deliverable

The final Beaty-Warren Middle School Educational Specifications will be completed and submitted to the District for approval. The final educational specifications will be in written and graphic form for review and clarification and will define the scope of work and design requirements. It will contain results of the planning labs, a compilation of space, program illustrations, and spatial diagrams for each program and the entire facility.

The Middle School Educational Specifications will be composed of the following components:

Overview and Vision Statement

A vision statement is a general philosophical vision of the educational environment, the number of students to accommodate, and how the students are to be served.

* General Considerations

General considerations are statements about the program and/or building that apply to all or most aspects of the building. They help provide a guide for the overall building.

- Aesthetics
- Safety & Security
- Technology
- Community Use/Public Spaces
- Green/Sustainable Considerations
- Site

Space Requirements

This section will provide tables and illustrations of the spaces to be included in the high school project. The compilation of space identifies the number and sizes of educational, support, and administrative areas. The illustrations define the overall program relationships and adjacencies.

Program Requirements

For each program and support area, tables, illustrations, and descriptions of each program area will be developed. This will provide information regarding the size, quantities, as well as outline special requirements such as technology, lighting, plumbing, furniture and equipment. The program areas that are likely to be addressed include:

- Core Academics [English, Math, Social Studies, Science]
- Foreign Language
- Career Technology
- Special Needs/Special Education
- Visual Arts
- Performing Arts
- Band/Instrumental
- Choral Music
