9135 <u>Curriculum Review Cycle</u>


The Board of Directors supports financially and encourages development of a District-wide, articulated curriculum that conforms to State of Pennsylvania mandates and is responsive to the needs of children in a rapidly changing society. The curriculum design will include: content, teaching strategies, learning activities, integration of technology, resources and assessments, test taking strategies and skills, integration of other disciplines, alignment with state and local standards, special education/inclusion components, remediation components, and gifted education components.

- Curriculum areas will be developed and/or reviewed every 6 years as designated in the Curriculum Cycle.
 - Review of curriculum includes review of instructional materials but does not necessarily imply the adoption of new materials. It is the responsibility of the curriculum coordinators to review and monitor the specific curriculum area on a yearly basis to insure compliance with the Pennsylvania academic standards.
- Curriculum development includes the writing of planned instruction based upon research, best practices and the current Pennsylvania academic standards. Curriculum development typically includes the adoption of new instructional materials.
 - As educational leader of the district, the Superintendent shall be responsible to the Board for the development of curriculum, and shall establish procedures for curriculum development which insure the effective participation of teaching staff members as appropriate to their age and grade and the community when called upon.
