<u>10450</u> Interscholastic Athletics

The Board recognizes the value of a program of interscholastic athletics as an integral part of the total school experience to all students of the District and to the community.

An interscholastic activity will be regarded as District sponsored only upon the approval of the Board.

It shall be the policy of the Board to offer opportunities for participation in interscholastic programs to male and female students on an equal basis as is practical and in accordance with <u>State regulations.</u> applicable laws and regulations.

The Board shall determine the standards of eligibility of all students participating in the interscholastic program. Such standards shall require that each student be covered by student accident-medical insurance or its equivalent, be in good physical condition, be free of injury and shall have fully recovered from illness as determined by a physician, before participation in any interscholastic athletic events.

The Board further adopts those eligibility standards set by the constitution of the Pennsylvania Interscholastic Athletic Association.

The Superintendent is designated by the Board to have authority over the entire athletic program.

The Board authorizes the Superintendent or his/her designee to develop procedures on an as needed basis to address needs.

In preparing these procedures, the Superintendent is directed to issue procedures which are consistent with the mission of the District as enunciated in the Policy Manual or other directives of the Board. The proceduresimplemented by the Superintendent shall remain in effect until supplanted by the Board. The Superintendent or his/her designee is directed to update annually the <u>Athletic Handbook</u>. The Handbook shall contain procedures to support this athletic policy including but not limited to rules, responsibilities and duties of all coaches and volunteers and other staff involved in the athletic program.

Fundraising must be approved and supervised by the principal; funds raised will be used solely to reimburse the District for costs advanced by the District for that activity. If a student helps in raising funds to support their activity, this does not guarantee a position or preferential treatment as a member of that team. If a student does not participate in raising funds to support the activity, he/she will not be denied a position on the team or receive non-preferential treatment as a member of the team.
