2. New Business

2.1 Preliminary Budget Adoption

Preliminary Budget Adoption 8-0-0 <u>MOTION</u>: It was moved by Mr. Knapp and seconded by Ms. Paris that the Board of School Directors approves the preliminary budget as presented; authorizes the administration to submit the preliminary budget and proposed tax rate increases to PDE on or before January 30, 2012; and authorizes the administration to publish the required notice of intent to file for referendum exceptions on or before February 2, 2012. The administration is directed not to apply through PDE for any referendum exceptions until the administration receives further direction from the Board following the special meeting to be held on February 8, 2012.

The result of the vote: passed unanimously.

2.2 Negotiations Committee

<u>MOTION</u>: It was moved by Mr. Knapp and seconded by Ms. Paris that the Board of School Directors directs its Superintendent's Special Negotiations Committee and the Meet & Discuss Committee to begin the process of meeting with the labor groups to discuss salary freezes for the 2012-2013 budget year.

<u>FRIENDLY AMENDMENT</u>: Mr. Werner moved that the benefits packages be added to the discussion with the labor groups. Both Mr. Knapp and Ms. Paris agreed.

FRIENDLY AMENDMENT: Mr. Grant moved that the motion read "to begin the process of meeting with the labor groups to discuss adjustments to the labor contracts for the 2012-2013 budget year." Mr. Werner, Mr. Knapp and Ms. Paris agreed.

The result of the vote: passed unanimously.

Mrs. Zariczny stated that she would be appointing Mrs. Nancy McDanel to the Superintendent's Special Negotiations Committee.
