The District recognizes the importance of ensuring the safety of students participating in the district's athletic programs. This policy has been developed to provide guidance for prevention, detection and treatment of concussions sustained by students while participating in an athletic activity.

 - 4. Practices, interschool practices and scrimmages for all athletic activities.

- 39 Each school year, prior to participation in an athletic activity, every student athlete and his/her
- 40 parent/guardian shall sign and return the acknowledgement of receipt and review of the
- 41 Concussion and Traumatic Brain Injury Information Sheet.

- 1 The Superintendent or designee shall develop administrative regulations to implement this
- 2 policy, which shall include protocols for concussion management.
- 3
- 4 The school may hold an informational meeting prior to the start of each athletic season for all
- 5 competitors regarding concussions and other head injuries, the importance of proper concussion
- 6 management, and how preseason baseline assessments can aid in the evaluation, management
- 7 and recovery process. In addition to the student athletes, such meetings may include
- 8 parents/guardians, coaches, other appropriate school officials, physicians, neuropsychologists,
- 9 athletic trainers and physical therapists.

- 11 <u>Removal From Play</u>
- 12
- 13 A student who, as determined by a game official, coach from the student's team, certified athletic
- 14 trainer, licensed physician, licensed physical therapist or other official designated by the district,
- 15 exhibits signs or symptoms of a concussion or traumatic brain injury while participating in an
- 16 athletic activity shall be removed by the coach from participation at that time.

18 <u>Return To Play</u>

- 20 The coach shall not return a student to participation until the student is evaluated and cleared for
- 21 return to participation in writing by an appropriate medical professional. The Board may
- designate a specific appropriate medical professional(s) to provide written clearance for return toparticipation.

27 All coaches shall annually, prior to coaching an athletic activity, complete a concussion

- 28 management certification training course offered by the Centers for Disease Control and
- 29 Prevention, the National Federation of State High School Associations or another provider
- 30 approved by the Department of Health.
- 3132 <u>Penalties</u>

A coach found in violation of the provisions of this policy related to removal from play and
return to play shall be subject to the following penalties:

- For a first violation, suspension from coaching any athletic activity for the remainder of
 the season.

 2. For a second violation, suspension from coaching any athletic activity for the remainder of the season and for the next season.
