To Promote Student growth and achievement, an effective school board models responsible governance and leadership by staying current with changing needs and requirements by reviewing educational literature, attending professional development opportunities prior to board service and continuously during board service; and preparing to make informed decisions and interacting with school officials in other districts and using resources provided by organizations and agencies committed to effective governance and management of public schools.

		and not just for the area they represent. She
		is concerned about forcing the kindergarten
		to attend Warren Area Elementary when

		want the students to be crowded in any
		school. Mrs. Cummings thinks that it
		would be in the best interest for Central
		Office to stay where they are rather than
		move to Russell before Eisenhower is ready
		to accommodate all of the students. She
		does not want 30 students in a class

2.0 New Business

2.1 Resignation

Resignation of Brandon Hufnagel Acknowledged 8-0-0 <u>MOTION</u>: It was moved by Mrs. Zariczny and seconded by Mr. Knapp that the Board of School Directors hereby acknowledges receipt of the letter of resignation submitted by Brandon Hufnagel, and agrees that said resignation shall be effective on February 5, 2013.

The result of the vote: passed unanimously.

Mr. Stewart asked that Roberts Rules of Order be suspended to hear from Mr. Tom Templeton, Assistant Executive Director, School Board and Management Services for Pennsylvania School Boards Association to address the proposals and goals for the superintendent search.

Mr. Temple described the Administrative Support Option and the Executive Search Option.

Considerations that need to be taken into account are Act 141 and Act 82 which state the superintendent evaluation must be based on the objective performance standards which are imbedded in the contract and evaluation instrument and listed on the district website. The Board is obligated annually to evaluate the superintendent and place on the website whether or not the superintendent was successful in meeting objective performance standards.

PSBA will conduct a community survey to establish a leadership profile, and the Board will analyze the candidates against that profile and develop interviews that reflect that profile.

The Executive Search Program cost is \$10,950, and the Administrative Support Search Program cost is \$5,500.

There is also a hybrid option that would allow the district to add options to the Administrative Support Program if additional services were desired.

Mr. Templeton stressed the importance of looking for a strong organizational leader with a solid educational component, and both search programs are designed to keep the focus on point.

Mr. Stewart reinstated Roberts Rules of Order.

2.2 PSBA Superintendent Search Services

MOTION: It was moved by Mrs. Zariczny and seconded by Mr. Grant that the Board of School Directors authorizes the retention of PSBA Executive Search Services, utilizing its Executive Search program for the purpose of conducting a Superintendent search for the Warren County School District.

The result of the vote: passed unanimously.

Austin & Son, Inc. in the amount of \$8,613,688 for the base bid; a General Construction Contract #1203.1 to E.E. Austin & Son, Inc. in the amount of \$3,625,883 for the base bid and alternate GC-7; a HVAC/Mechanical Contract #1002.2 to Rabe Environmental Systems, Inc. in the amount of \$2,795,329 for the base bid; a HVAC/Mechanical Contract #1203.2 to Rabe Environmental Systems, Inc. in the amount of \$559,115 for the base bid and alternates HC-4 and HC-5; a Plumbing Construction Contract #1002.3 to Wm. T. Spaeder Co., Inc. in the amount of \$1,674,769 for the base bid and alternates PC-3 and PC-4; a Plumbing Construction Contract #1203.3

- Mrs. Horner has taken the lead on working with Dr. Kennerknecht on the Beaty-Warren Middle School project working through the first phase of that construction project and planning the second phase of the project with Mrs. Decker.
- Mr. Weber is working with Dr. Kennerknecht and administration at Eisenhower on the building project there.
- There needs to be discussion on the grade level configuration at Beaty-Warren Middle School for the 2013-2014 school year.
- The grade level configuration for Warren Area Elementary Center needs to be established for the 2013-2014 school year.
- Discussion needs to occur on the closure of South Street Early Learning Center.
- The grade level configuration for Russell Elementary and Sugar Grove Elementary will be reviewed in relationship to the Eisenhower project.
- If the Board makes Beaty-Warren Middle School a 6th 8th grade facility and Warren Area Elementary Center a K 5th grade facility, decisions would need to be made on where to house the emotional support program.
- Keeping WAEC a 2nd 6th grade facility and South Street Early Learning Center remaining open would negate any savings that were projected for the closure of the school.
- Fifth grade students at Sugar Grove and Russell Elementary will remain in their respective buildings next year due to the construction at Eisenhower Middle High School.
