3.1 Facility Rental Fees

Discussion:

Board reviews the fee schedule and the accompanying policy for building rentals in December for the upcoming calendar year. Administration is not recommending any changes to either the fees or the policy for 2014.

3.2 Discussion: Vacant Facilities

Discussion:

With completion of construction projects, the following district facilities are not, or will not be used to house students: Sheffield Elementary School (SES), Allegheny Valley Elementary School (AVES), Sugar Grove Elementary School (SGES), Russell Elementary School (RES) and South Street Early Learning Center (SSELC). Other vacant district buildings include the Anderson building and the former Pleasant Elementary School. There has been some public inquiry regarding the disposition of these properties.

At the direction of the committee plans are underway for the following buildings/dispositions:

- RES 50% of the building for student use, and 50% of the building for WCSD Central Office space
- Anderson Building WCSD maintenance department
- Pleasant Township remain as a District warehouse for the foreseeable future; reevaluate at a future time
- SSELC vacant and not used; committee has directed this building to be declared "unused and unnecessary" and sold via sealed bid
- SGES building is occupied until construction is complete in August 2014, then will be vacant and not used; building to be sold at that time
- SES vacant and not used; committee has directed this building to be declared "unused and unnecessary" and sold via sealed bid
- AVES building is occupied until construction is complete in August 2014; WCSD's server farm is located there, time and effort and dollars involved in upgrading, moving and relocating; rest of building could be leased; building to be sold when no longer being used for students

Action:

Forward motions to December 5, 2013 Board meeting to (1) declare SES and SSELC "unused and unnecessary property" and (2) to begin process of selling buildings via sealed bid as per school code.

<u>Motion 1 – Declaring Sheffield Elementary School Unused and Unnecessary:</u> That the Board of School Directors declares the Sheffield Elementary School to be unused and unnecessary.

Motion 2 – Sale of Sheffield Elementary School:

That the Board of School Directors makes a finding that under the facilities master plan as being implemented by the Board, that Sheffield Elementary School be sold by sealed bids on the terms and conditions set forth on the attachment including the provision that until August 31, 2014 the District except and reserve to itself the exclusive use and possession of the premises and that the deed of conveyance incorporate said exception and reservation. <u>Motion 3 – Declaring South Street Early Learning Center Unused and Unnecessary:</u> That the Board of School Directors declares the South Street Early Learning Center to be unused and unnecessary.

Motion 4 – Sale of South Street Early Learning Center:

That the Board of School Directors makes a finding that under the facilities master plan as being implemented by the Board, that South Street Early Learning Center be sold by sealed bids on the terms and conditions set forth on the attachment including the provision that until August 31, 2014 the District except and reserve to itself the exclusive use and possession of the premises and that the deed of conveyance incorporate said exception and reservation.
