- Nutrition would like to offer coffee at the high school level only 9-12 can have it, one creamer and one sugar; in other school districts it has increased breakfast sales.
- Would like to start at Warren and Youngsville; a plan to separate the middle level students from the high school students in other buildings needs to be figured out
- Mr. Norbert Kennerknecht and staff are hard at work trying to drop lines/feeds to get POS systems in place
- Summer Food Program 4,000 last year; estimate of 2,675 breakfast and 6,285 lunches this year
