3.10 14-15 Athletic 3rd and 10th Day Participation Numbers - PACCA – Mrs. Marcy Morgan

<u>Discussion:</u> There are three schools that have numbers below the minimum participation number. The District is in the process of sending notification to the coaches, principals, and athletic directors that they will be placed on probation and will need an action plan. The District is discussing sending warnings this year when a team is getting close to the minimum number so the coaches, principals and athletic directors will be aware and can take action to increase numbers. The District is looking at the gender equity issue to make sure the District is in line with Title IX. The District is finalizing Title IX reporting this week. The District is reviewing policy on minimum number requirements for different sports and addressing development of an action plan for below minimum numbers. Two high schools are near the minimum number for band. The bands are pulling numbers from the lower grade levels to increase numbers.
