10107 School Attendance Areas

The following represent verbal descriptions of the attendance area boundaries. The attached map of the attendance area boundaries is intended to visually represent said descriptions. When making student assignments pursuant to Policy 10102, the Superintendent or his/her designee is authorized to deviate from the attendance area boundaries if the Superintendent or his/her designee determines that it is in the best interest of the District to do so for reasons including, but not limited to, transportation efficiency, to appropriately balance the student population amongst schools, or to relocate students during a construction project.

Decisions for any such deviations shall be made by the District at its sole discretion pursuant to 24 P.S. §13-1310 and in accordance with the following process:

1. The decision shall initially be made by the Superintendent.

2. The decision shall then be presented to the Board of School Directors at a public meeting for approval of the Superintendent's decision. If the Superintendent's decision is approved by the Board, the student(s) shall remain in the attendance area assigned by the Superintendent. If the Superintendent's decision is rejected by the Board, the Board shall determine the attendance area to which the student(s) will be assigned.

3. Once the attendance area assignment has been approved by the Board. the assignment shall remain in effect and shall only be changed upon Board approval of the change at a publicly held meeting, unless a transfer request that does not require Board approval is submitted on behalf of a student and approved by the Superintendent pursuant to Policy 10102.


