Dr. Clark commended the Booster Club for their willingness to step up and said that the Board will take a look at their request during the budget process. Mr. Arthur

Stewart asked what the Booster Club provides for the band beyond money towards new uniforms. Marcia White responded that they provide everything including the music, some instruments, a small instrument repair budget, funds for the marching band show, props, the guard uniform, an assistant director and a trailer to get the band from one place to another. The band receives nothing form the Warren County School District.
