The goal of this course is to continue the exploration the psychological facts, principles and phenomena associated with personality, learning, memory, consciousness, intelligence, psychological disorders, therapy and social psychology. Another goal of the course is to encourage critical thinking and good writing. Writing should be clear and concise, and demonstrate knowledge of psychological concepts using appropriate terminology. Emphasis will be placed on the analysis, synthesis, and evaluation levels of critical thinking. **A final exam is required.** 

It is hoped that the knowledge of psychological inquiry will provide perceptions of the world around us, insights into one's own and into others' behavior, as well as an appreciation of the complexity of human behavior.
