#### 5.1 Other

Mr. Jim Grosch will address the budget later on but Ms. Amy Stewart said that the Administration is ready from a personnel standpoint to add positions based on the add list that the district has been working on. The list includes:

- Central Office Class A Secretary for volunteers
- 2 Academic Coaches
- Special Education Teacher for YHS for work in a transition classroom
- Guidance Counselor
- EMHS Custodian to help with food
- WAHS Teacher Aide to assist with alternative education
- 3 Elementary Teachers to be added back from the cut list with 1 additional
- Elementary intervention dollars require more conversation, recommendations would come at the end of July.
- The district will be able to remedy class sizes at Eisenhower Elementary
- Contingency dollars for kindergarten

Given the scheduling of the next committee meeting, Mr. Arthur Stewart asked if it would behoove the district for the Board to vote tonight at the Special Board meeting on the 2 elementary intervention positions. Ms. Amy Stewart said that the positions have not yet been identified but it would be helpful if the Board gave approval to hire up to a certain point if they are comfortable with the Administration's recommendations.
