3.6 15-16 Winter Third/Ten Sports Numbers

Discussion: Sports with below minimum participation numbers are put on probation and an action plan is created. If the action plan is not working after one year the sport goes to the next phase. This is year two for Junior High wrestling at Sheffield and Youngsville. Year two requires a meeting with the principals and athletic directors to go through a five item list for review after which the results are brought to the Board. The recommendation to cancel a sport must come from the Board. The Administration will report back to the Board regarding Junior High Wrestling.

The added cost of \$30 to \$40 for wrestling officials is combined together for Junior High and Varsity wrestling.

The topic of combining wrestling at the county level was brought up and whether it could be considered. The receptivity of parents to the idea and policy will dictate how and when the topic can be discussed and whether it will be considered.
