## 4.4 Beaty Roofing & WCSD Maintenance Vehicles

### Discussion:

Administration presented a slideshow of pictures of the inside of the Beaty-Warren Middle School, depicting the evidence of roof leaks. The roof warranty on BWMS has expired since the completion of the renovation project, and the school will need a new roof in the near future. It is estimated that this will cost between 1.1-1.4 million dollars.

The WCSD's Maintenance Vehicle Fleet is aging. Currently 9 out of the 12 vehicles have over 100,000 miles on them. The oldest is from 1999 and has 200,000 miles on it. Additionally, 2 of the 3 vehicles in the snowplow fleet will not pass inspection and will need to be replaced.
