#### 1.8 Public Comment

Prior to public comment, Mr. Christopher Byham, Solicitor, reviewed the policies and procedures governing the Public Comment portion of the Board meeting. Mr. Byham reminded those in attendance that Board Policy 2401, Board Policy 2405, Board Policy 2410, Board Policy 2422 and Board Policy 2425 all govern how the Board receives comment during the Board meeting. There are two sections of public comment during a board meeting – one at the beginning, and one at the end. Individuals in attendance were asked to remember that the law mandates that each person state their name prior to speaking, and all comments should be directed to the Board President. Public comment portions of the Board meeting are not in a question and answer format; therefore, the Board would not address any questions posed to them during Public Comment. Mr. Byham stated he would monitor the time restraints relative to public comment, and the Board President has the authority to terminate public comment and/or recess the Board meeting at any time if necessary.

Tony Tridico	Warren, PA	Mr. Tridico stated he felt that the situation between the Board and the teachers is not a new situation. He requested a new negotiation group, and a removal of the lawyer.
Susan Wilson	Warren, PA	Gave her time to Jennifer Long.
Jennifer Long	Warren, PA	Ms. Long stated she is an educator, wife, mother and community member. She felt her decision to work in WCSD has created chaos in her life; however, it has also allowed her to grow as a person. Ms. Long thanked her fellow teachers for their support, and offered to help the District improve their image.
Donna Anderson	Warren, PA	Ms. Anderson spoke regarding the strike. She asked the Board for a new negotiation team, and to dismiss

		Mr. Fanelli.
Piper VanOrd	Warren, PA	Ms. VanOrd is a parent of three children at WAHS, and a small business owner in Warren County. She stated she has attended every School Board meeting since August. Ms. VanOrd questioned why the teachers did not yet have a contract. She feels there is a disconnect between the Board and the teachers in the classroom. Ms. VanOrd called for a new negotiation team and a new lawyer.
Doug Ward	Warren, PA	Mr. Ward grew up in Warren, and considered himself fortunate to attend the WCSD while growing up. Mr. Ward urged the Board to restore the teachers' benefits immediately. He felt the teachers had waited patiently for a contract. Mr. Ward asked the board to dismiss their labor counsel, and replace those on the negotiations team who have destructive attitudes. He urged the Board to move forward in an ethical and constructive manner.
Kristopher Bunk	Warren, PA	Mr. Bunk stated he is a parent of two children in the WCSD, a taxpayer, and the spouse of a teacher. Over the past 883 days he has never heard his wife say that she deserved a pay raise. In the 15 years his wife has been a teacher, he has never heard her say that she should make more money. His wife cares deeply about her students and feels the current lack of contract is due to the fact the Board does not like the teachers. Mr. Bunk stated his wife is proud to be a WCEA member.
		He urged the Board to come to a resolution and end the chaos involved with the strike.
Derek Nowacki	Student at Warren Area High School; Warren, PA	Mr. Nowacki is a senior at WAHS and child of a teacher, and feels the Board has failed the students by being stubborn and unfair in negotiating, and he feels the community wants the teachers to have a fair contract. Mr. Nowacki stated that in his opinion, the Board removed health benefits from the teachers without adequate notice, and given time, the teachers could have prepared for the situations that occurred. He called for the Board to end the strike and give the teachers a fair contract prior to the end of the meeting.
Charles Davidson	Warren County, PA	Mr. Davidson stated that he was attending the meeting to represent the Communication Workers of America Local 30,000 who support the teachers 100%.
		Gave the rest of his time to Debbie Care.
Debbie Care	Warren, PA	Ms. Care is a Warren county resident and taxpayer. She questioned why the teachers' insurance benefits were cut without notice, and if they were going to receive a refund of their already paid October premiums. Ms. Care questioned how much it was

		going to cost to reinstate the teachers' benefits when the strike was over. She felt the Board is not treating the teachers with respect, and cannot put their personal feelings aside. Ms. Care feels that there are great teachers working in the WCSD.
		Ms. Care asked the Board to consider moving all future Board meetings to a venue large enough to accommodate the public. Ms. Care requested a motion for a new School Board negotiating team and legal counsel. She feels the Board owes it to the students, teachers and taxpayers to bring the strike to a quick resolution.
Anita Harris	Sheffield, PA	Ms. Harris is a former student of the WCSD, and a mother of several children currently in the WCSD.  Ms. Harris spoke about one of her children attending SAES and the services that he has received. She feels that her son needs his teachers, and has had some of the best teachers. She would like teachers to have a fair contract, and feels it is disingenuous to give Superintendents a raise, and not the teachers.
		Ms. Harris asked for the District's lawyer and negotiations team to be replaced.
Gale Boocks	Oil City, PA	Mr. Boocks stated he is a taxpayer in Venango County and his taxes support the school system. He reminded the Board that Jesus was a teacher and took care of the children.
		His niece works in the WCSD, and he feels there is a lot of darkness in the WCSD. Mr. Boocks would like the Board to take care of the children.
Sonya Irons	Youngsville, PA	Ms. Irons graduated from SAMHS and has a son in the WCSD. Her son has intellectual disabilities and ADHD. She struggles with how to explain the strike to her son. Ms. Irons is worried that her son will move backwards during the strike.
		She feels the teachers of the WCSD shouldn't have to wait this long for a contract. She stated the teachers are the heart and soul of the WCSD, and her son knows all the teachers, but does not know the Board. Ms. Irons stated her son deserves an education.
Amy Elizabeth Huffman	Warren, PA	Ms. Huffman stated that the public relies on the Board to make educated and financially sound decisions. She questioned when the Board last thought critically and solved a problem. Ms. Huffman questioned why the administrators received a raise over the past three years; however, the teachers did not. Ms. Huffman feels the strike is a hardship for the whole community. She stated she has lost faith in the School Board.

Logan Beard	Warren, PA	Mr. Beard stated that he lives in the City of Warren, and is not a parent, simply a concerned community member.	
		Mr. Beard read a letter written by a former community member. The author of the letter feels that the School Board's decisions tell teachers that they don't matter and that their lives are not as important as the bottom line. The author of the letter supports teachers and feels that they are important. He would like the Board to consider a change of heart and show the teachers how much they matter.	
Matt Menard	Warren, PA	Mr. Menard stated he is a school counselor in the WCSD. Mr. Menard feels the teachers, and not the buildings, are the assets in the WCSD. He feels the Board does not understand that the assets are the professional staff, administrators and support staff that work with the children every day. He would like the Board to treat teachers like assets and not machines. Called on the Board to invest their budgeted revenue wisely.	
Jennifer Lynds	Warren, PA	Gave her time to Aaron Stearns.	
Aaron Stearns	Warren, PA	Mr. Stearns addressed the Board regarding the teachers' situation. He stated he feels that in the last 833 days negotiations have been unproductive and this has greatly affected the community. Mr. Stearns stated the WCEA showed good faith when they opened the last contract, and called on the Board to do the same. He would like a motion to replace the current negotiating team and show the community the Board has the children's best interests in heart.

The Board has received several questions from teachers and community members, and the Board members themselves have questions. Mr. Fanelli introduced his presentation. He stated the purpose of the presentation was to address the questions about the process of negotiations, as well as the contract and the status quo. He emphasized the presentation included several financial charts; however, the one chart that was not present is a chart depicting the value of a teacher. Mr. Fanelli relayed that the presentation, and the bargaining, is a reflection of the financial picture of the District and not the District's opinion of the worth of teachers.

Mr. Fanelli provided information in his presentation regarding: WCEA average salary versus Warren County per capita; the average cost of benefits for private industry versus WCSD teachers; health insurance information; information regarding the amount the District pays annually into the Pennsylvania School Employees Retirement System (PSERS); current and proposed salary information and raises for teachers; information regarding the District's fund balance as well as historical property tax rates and information; and comparison of the latest proposals offered by the WCSD and the WCEA negotiation teams.
