The above mentioned parcel is located in Tidioute Borough at 3 Economy St. This property was declared blighted by the Blighted Property Committee in May of 2017; it then went through the process, and has been in the hand of the Warren County Redevelopment Authority (RDA) for many months. We (RDA) had sat on this property hoping this property would have been sold at the judicial sale, but it did not.

This dwelling had a fire a couple of years ago, and since then the owner has passed away. We feel that this is an accident just waiting to happen and needs to be taken care of.

We understand that the starting bid from repository is \$850.00. The RDA is making a request that this amount be waived so that the RDA can take ownership and demolish the structure or could we purchase this for a minimum bid of \$100.00.

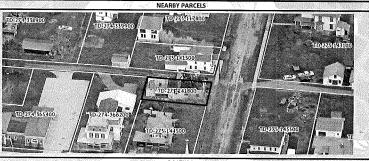

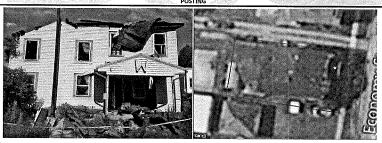
