#### **FUNDATIONS INTRODUCTORY WORKSHOPS**

#### FUNDATIONS VIRTUAL IMPLEMENTATION SUPPORT – DEDICATED COHORT



The Virtual Implementation Support program offers support to teachers who are new to Fundations. Teachers are enrolled in a level-specific cohort with a dedicated Wilson Literacy Specialist and attend five (5) live interactive sessions at timely intervals throughout the year. Each teacher can receive two (2) 15-minute, virtual meetings that are one-to-one with his/her dedicated Wilson Literacy Specialist. Content on the online Learning Community for Fundations is curated "just-in-time" and access to a discussion board for the level-specific teachers fosters a community of practice.

A minimum of 10 teachers is required for a level-specific cohort. (Additional fee required beyond 20 participants in a level-specific cohort.) Completion of the corresponding Fundations level-specific workshop is required to participate in the Virtual Implementation Support program.

Principals will have access to ongoing support to foster successful implementation through the WIN-Prin Network – a virtual community for principals and administrators new to implementing Fundations programs with curated resources and live webinars designed to explore key conditions that support successful implementation during early adoption.
