Course Title: Communications 9

Course Description: Communications is a course designed to teach students who need functional communication skills at the most basic level. This course expands on the foundation of English Language Arts concepts such as relationships, analysis, interpretations, vocabulary development, spelling, hand writing, fluency, listening/following directions and speaking skills, writing applications, personal demographics and basic comprehension. Using the Pennsylvania Common Core Standards and the Pennsylvania Alternative Standards as a guide, the course will prepare students for the Pennsylvania Alternate State Assessments. This course is limited to teacher recommendation based on specific student need.
